





We hereby warranty Glide-Lock Siding Hanger to be free from defects in material and workmanship in the manufacturing process. We further warranty the Glide-Lock Siding Hanger to perform as follows: The siding panel of which it is properly installed will expand and contract freely and without restriction due to product failure of any kind.

Glide-Lock Siding Hanger is rated so that the siding will remain attached at the connection point to the home of winds not to exceed those of category 5 hurricane, providing the installation is with Glide-Lock screws as per the installation instructions provided.

This warranty will be in conjunction with the siding manufactures warranty of which the hanger is installed. Furthermore the installation instructions of Glide-Lock and the vinyl siding institute installation instructions must be followed with the exception of the fastening schedule as outlined within manufacturers instructions and those listed within the vinyl siding institute installation manual concerning the fastener and fastener spacing.

Glide-Lock Mfg. Inc. does not assume any liability for defects in the actual siding panels or fasteners used in the application unless purchased from Glide-Lock Mfg, Inc. This warranty shall remain in effect for as long as the home of which the siding hanger is installed is habitable. Replacement product and or siding panels that may have warped or buckled due to the actual failure of the siding hanger will be replaced at sole expense and discretion of Glide-Lock Mfg, Inc.

<u>Glide-Lock Siding Hanger Warranty Disclaimers:</u>

Siding installed with any other fastener than Glide-Lock screws or Tapcon screws when installing directly over masonry as noted within the installation instructions will not be covered under this warranty.

Siding products that have been installed with contoured insulation or flat foam insulation other than approved by Glide-Lock.

Siding that has been installed other than as per the Glide-Lock installation instructions will not be covered under this warranty.

Manufacturing defects in vinyl siding of any kind will not be the responsibility of Glide-Lock under this warranty.

In the event of a hurricane, tornado, wind storm or high winds of any type causing the siding panel failure where the panels lock together itself and not at the attachment of the Glide-Lock Siding Hanger will not be covered under this warranty.

Siding that is not listed on the approved manufacturers page of the Glide-Lock website will not be covered under this warranty.

Glide-Lock reserves the right to insect, photograph and video any project filing a claim. Glide-Lock reserves the right to replace, repair and or correct any claim as filed under this warranty at its own discretion.
