

# UltraCare Sealer for Glass Tiles & Shower Doors



## DESCRIPTION

*UltraCare*® Sealer for Glass Tiles & Shower Doors is specifically designed to keep glass tiles and shower doors cleaner for longer. This easy-to-use formula uses advanced chemical technology that becomes part of the surface, creating a barrier that causes water to bead and slide off glass surfaces. Continued use of this product helps to repel the buildup of soap scum, calcium, hard water deposits and grime onto glass surfaces, significantly reducing cleaning time and effort.

- Transparent hydrophobic barrier technology helps to reduce soap scum, calcium, hard water deposits and grime from building up on and sticking to glass surfaces
- Makes cleaning of hard water and other contaminants quicker and easier

- Does not streak or smear

## PRODUCT APPLICATION

Before product use, take appropriate safety precautions. Refer to the Safety Data Sheet for details. Read all installation instructions thoroughly before installation.

Due to variations between surfaces, sample testing is recommended to maximize performance and suitability for intended use.

1. Ensure that the surface is clean, dry and prepared for product application.
2. Spray the product onto the glass surface or onto a new microfiber towel. Wipe the glass using a firm, circular and overlapping motion.
3. Allow the surface to dry until a slight haze appears.
4. Repeat Step 2 to ensure complete and uniform coverage.
5. Remove the final haze with a dry microfiber towel or dry cloth until glass is crystal clear.
6. If streaking or hazing is still noticeable, rebuff with a wet microfiber towel or damp cloth.
7. Reapply the product as often as needed to help keep glass clean – typically once every 2 to 4 weeks.

## PROTECTION

- Protect such non-glass exposed surfaces as wood, carpet and landscaping before product use.
- Keep the container closed tightly when the product is not in use.
- Keep out of reach of children and pets.
- Do not get in the eyes. If this product gets in the eyes, rinse with running water for several minutes. If irritation persists, seek medical attention.
- Store at room temperature in the original container. Do not freeze. Keep away from heat, sparks and open flames.
