APPLICATION INSTRUCTIONS

SURFACE PREPARATION

Remove all deteriorated concrete, dirt, oil, grease, and all bond-inhibiting materials from surface. Preparation work should be done by high pressure water blast, scabbler, or other appropriate mechanical means to obtain a surface with a minimum of CSP 3 profile or greater. Ensure there are no curing compounds or other contaminants remaining on the substrate before application. Substrate must be dry before application.

MIXING

Prior to installation, stir Sika® LiquidWeld Blu before use for consistent dispersion. Apply Undiluted (no water needed)

LIMITATIONS

- Not for use in wet environments, in or around swimming pools, showers, decks, below grade or retaining walls that may be subject to hydrostatic pressures, side walks, or parking ramps.
- Do not dilute.
- Do not apply onto water soluble substrates.
- Do not apply on frozen or frost covered substrates.
- Low temperatures or high humidity will extend curing
- Do not allow stored product to freeze.
- If substrate gets contaminated or wet, a recoat is required.
