Vendor represents and warrants that the Claim(s) are appropriate for use in connection with the Product and that no such use could be deemed to constitute an unfair or deceptive statement as to any element of the Product. Vendor further represents and warrants that the Claim(s) are accurate and truthful, and that such Claim(s) have been tested, validated, and substantiated in accordance with all applicable rules, regulations, and law and that Vendor shall promptly notify Lowe's and Lowe's Legal Department in writing if such Claim(s) are no longer valid and substantiated in accordance with applicable rules, regulations and law. To the extent that Vendor is unable to substantiate the Claims and/or requests that Lowe's discontinue displaying any Claim(s) in any packaging, signage, marketing, advertising, brochures and/or other promotional efforts (collectively, "**Marketing Materials**"), Vendor shall pay for such replacement Marketing Materials. Vendor understands and agrees that:

- (i) Lowe's use of the Claim(s) is fully dependent upon Vendor's representations and warranties regarding the Claim(s);
- (ii) Lowe's is relying exclusively on Vendor's representations and warranties regarding the Claim(s) and/or the Product; and
- (iii) the Claim(s) are, for all purposes between the parties, to be deemed a part of the Product.



Vendor agrees to defend and indemnify Lowe's and its affiliates and subsidiaries, including each of their employees, officers, directors, and agents (collectively, the "**Indemnified Parties**"), and to hold each of the Indemnified Parties harmless from, and promptly reimburse them for all payments of money (fines, damages, legal fees, expenses, etc.) by reason of any claim, demand, tax, penalty, or judicial or administrative investigation or proceeding whenever asserted or filed (even when negligence of Lowe's and/or any of the Indemnified Parties is alleged) arising or resulting from Lowe's use of such Claim(s); however, notwithstanding anything to the contrary, the indemnification provided by the preceding is in addition to any indemnity and/or insurance obligations provided by Vendor under any other agreement between the parties. - (ii) Lowe's at its exclusive option, may back charge or set off any funds due to Vendor in respect to its damages or expenses to overcome any injunction or stoppage of importation of the Product; and
- (iii) nothing herein shall serve to lessen or restrict Vendor's obligations to Lowe's rights, including such right to back charge or set-off for any claim under any such other agreement between the parties.

Vendor agrees that Lowe's, in its sole discretion, may convert this letter into an electronic record and that in the event of any dispute involving this letter, a copy of such electronic record may serve as the exclusive original. Vendor consents to conducting business via electronic transactions and recognize the validity, enforceability and admissibility of any electronic record or any electronic signature created in connection with this letter or the relationship contemplated by it. Signed signature pages may be transmitted by facsimile or electronic mail, and any such signature shall have the same legal effect as an original. An electronic record of this letter and any electronic signature made in connection with this letter shall be deemed to have been signed by hand by the Vendor.
