### **4. First-aid Measures**

#### **Description of first-aid measures.**

##### **General advice.**

Move victim to a safe isolated area. Immediate medical attention is required. Call a poison control center or doctor for treatment advice.

##### **Inhalation.**

##### **Notes to physician.**

Treat symptomatically. Smallest quantities reaching the lungs through swallowing or subsequent vomiting may result in lung edema or pneumonia.

## 5. Fire-fighting Measures

### Extinguishing media.

#### **Suitable extinguishing media.**

Use: Dry powder. Alcohol-resistant foam. Carbon dioxide (CO<sub>2</sub>).

#### **Extinguishing media which shall not be used for safety reasons.**

Water may be unsuitable for extinguishing fires.

### Special hazards arising from the substance or mixture.

Thermal decomposition can lead to release of irritating and toxic gases and vapors. Most vapors are heavier than air. Vapors may spread along ground and collect in low or confined areas (sewers, basements, tanks).

### Advice for firefighters.

Evacuate personnel to safe areas. As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear.

## 6. Accidental Release Measures

### Personal precautions, protective equipment and emergency procedures.

#### **Personal precautions.**

Wear protective gloves/clothing and eye/face protection. Do not breathe vapors or spray mist. Avoid exceeding of the given occupational exposure limits (see section 8). Thoroughly decontaminate all protective equipment after use.
