SURFACE PREPARATION:

Cover all nail and screw heads with joint compound according to directions and sand to smooth surface.

Tape drywall and apply joint compound and allow to fully cure according to directions prior to priming.

Sand to smooth surface before priming.

Wipe off dust with a damp cloth, allow to dry thoroughly.

CLEAN UP:

Use soap and water to clean hands, tools and spills. For recycling or disposal of empty containers and unused product, contact your household refuse collection service.
