
### **IMPORTANT INFORMATION!**



### **AVOID SCRATCHES!**

### **ANTI-TOPPLE WARNING !**



Please purchase the wall attachment that fit your wall. If unsure, seek professional advice. Please read and follow each step of the instructions carefully.

### **IMPORTANT !**


It is important that any product which is assembled using any kind of screw is re-tightened 2 weeks after assembly, and once every 3 months - in order to assure stability through-out the lifespan of the product.

For regular maintenance and cleaning of the product, for the frame, please use a rag dipped in neutral detergent to fully wipe it, and then dry it with a clean rag. For glass materials, wipe with a rag dampened with water glass cleaner, and then dry with a dry rag.

Do not use an electric screwdriver, and do not use too much force when installing, because the board is easy to break.



Fix plastic part(L&R) to panel 8 using screw(D) as shown.


Attach panel 7 to the assembled part using screw(D) slightly to tighten, as shown.





Knock part(C1,C2) slightly into the holes in panel 2&3 as shown.




Attach panel 5 and 9 to panel 3 using screw(B) as shown.

Attach panel 2 to assembled part in step 4, using screw(B) and wooden dowel(A) as shown.



Fix panel 4 to the back of assembled unit using screw(I) as shown.


Knock part(H) into the bottom.




Install anti-tipping device with part(J3) and screw(B) as shown.


