



## **Cello UV Cart Warranty**

The Cello UV Cart product warranty is offered by Cello Lighting, Inc. Throughout this warranty, the terms "we", "us" and "our" refer to Cello Lighting, Inc.

We do not authorize anyone, including, but not limited to, Wholesalers, the subsequent purchaser of the product from a Wholesaler, or remote purchasers, to obligate us in any way beyond the terms set forth herein. We warrant our products to be free from substantial defects in workmanship and materials under normal household use in accordance with the instructions for warranty period following the date of purchase. We will, at our discretion, replace or repair any item requiring service. This warranty shall not apply to damage arising from neglect or accidental damage. Liability for consequential damages is expressly excluded. Proof of purchase is required.

### **Warranty Period**

We provide Three (3) years for Cello UV Cart. The Warranty Period starts at the date of purchase of the Product by the original end-user purchaser from an authorized Wholesaler.

### **Replacement/Credit**

If the product fails to meet the limited warranty conditions during the warranty period, we will, at our option, replace the product free of charge or provide you with a replacement of comparable value. Any replacement may be conditioned upon the return of the defective product to us at your own expense unless we receive the request for warranty service within 10 days of purchase.

### **What Our Limited Warranty Does Not Cover**

This warranty is effective only if the product is operated in the country in which it was purchased or in the country where it was shipped to. A product that requires modifications or adaptation to enable it to operate in any other country than the country for which it was designed, manufactured, approved and/or authorized, or repair of products damaged by these modifications, is not covered under this warranty. We offer this limited warranty only when the product is used by the original end-user. We offer no other warranty. Additionally, while our warranty is excellent, there are other limits to it. We offer NO WARRANTY in cases of damage in transit, inadequate care or neglect, abuse, abnormal use, accidents, normal wear and tear, damage due to environmental or natural elements, failure to follow product instructions, immersion in water, water damage to the base unit due to misuse, improper installation, improper storage or maintenance of the product or



improper service, or causes not arising out of defects in materials and workmanship. We do not offer warranty on accessories.

### **Disclaimer of Other Warranties**

The Express Warranties in the preceding section are exclusive and in lieu of all other warranties. However, to the extent applicable law does not permit disclaimers of certain implied warranties, such warranties are limited to the warranty period identified above. Some states and countries do not allow limitations on how long an implied warranty lasts, so the above limitations may not apply to you.

In no event shall we be liable for incidental, compensatory, punitive, consequential, indirect, special, or other damages. Our aggregate liability with respect to a defective product is limited to the monies paid to us.
