# Safety Instructions



Note Please retain these instructions for future reference

Please fix all screws and knobs before use, Please read and understand this entire manual before attempting to assemble or install the product. It should not be used as a toy or tool. Children should not engage in the operation, assembly, removal, or disassembly of the product

Every 3 months, determine whether all screws and knobs are tightened

During the initial assembly, do not tighten all the screws until fully assembled

Never leave unattended, fully opened, or use in windy conditions, gusts or storms

Note that some parts are heavy and have sharp edges, so you should pay attention to your hands being scratched when you take them

If any parts are broken, damaged, or missing, please do not attempt to assemble this product, please contact our customer service online

Please do not use the product in a way that is different from the manual, as this may result in the failure of the warranty

## Care & Maintain

If the umbrella encounters a humid environment, it needs to be dried in a sunny or naturally ventilated environment

Store in a dry place during the of' season

Keep the umbrella away from fire or heat sources.

Our umbrellas are suitable for home and leisure places such as courtyards, gardens, swimming pools, etc.

## Fabric Care


To spot clean, use mild soap with lukewarm water, rinse, and air dry.

# Assembly


## Step1

Place the part F upper crossbar on the part G lower crossbar , Make them coincide We are also equipped with 4 expansion screws, which can be fixed on the cross bar and fixed in the ground. Increase the stability of the umbrella




## Step2

Use part A , B screw fittings to fix the connection between part H and part F and G



## Step3


Fill the base of the sandbag with sand (the weight after filling is about 105 pounds) and then fix them on our crossbar



## Step4

Connect part E to part H , and tighten it with part I


(Note: Place the umbrella on a flat surface when assembling;  
put through the long screw ,then put through the short screw , last fix at one end and screw at the other )



Need to be fixed with cross  
type screws, (Not included)


## Step5 -Opening and Closing

Before opening, gently move the umbrella ribs and umbrella cloth to separate them  
Loosen the knob, and then grasp the position of the rocker to push the umbrella up  
Turn the shaking handle clockwise until the umbrella is fully extended and tighten the knob



## Step 6

When not in use, loosen the knob, fold the umbrella down, and fix it with the Velcro strap on the umbrella cloth surface



# WARRANTY

## Outdoor umbrella

### 2-year Warranty Program

For a period of two (2) years after date of purchase, the Manufacturer will either repair or replace defective components in accordance with this Limited Warranty. This warranty is between the Manufacturer and the original purchaser and is valid only when accompanied by the original purchaser's sales receipt showing original date of purchase and location of purchase. Replacements under this warranty revert back to the date of original purchase for future warranty.

The manufacturer or its authorized dealer can accept or reject warranty claims based on its findings. This warranty applies in normal residential use only and is not intended for commercial use. The Manufacturer can make substitutions as required of materials, components, and sub-components of comparable value and utility. This warranty is limited to product repair or replacement (to be determined solely by the Manufacturer). Warranty return is limited to only the single affected component.

This limited warranty covers only manufacturing defects and does not cover normal wear and tear, damage due to acts of nature (such as, but not limited to freezing or high winds), abuse or misuse, including chemical damage from suntan oil or other chemicals, exposure to extreme heat or cold, abrasion or excessive weight. This product is intended to be used in standard installations only. This warranty is void if the product is not used for its intended purpose. The Manufacturer disclaims liability for any aspect of installation and any inconvenience caused by a defective part of a component.

6. The fading caused by other external forces on the umbrella cloth surface is not included.
7. Umbrella bases are not covered under any circumstances.
8. Items sold "as is" or floor models.
