Push-Button Spark Ignition Kit

Use and Care Instructions

(AFP-INST-006_REVB_07/18)

The Push-Button Spark Ignition Kit is an alternative to traditional match lighting of an outdoor fire feature. Once installed, the operator can simply press the ignition button to produce sparks at the ignition probe tips to allow ignition of a fuel source (i.e. – natural gas or propane).

Parts included:

- Push-Button Spark Generator
- Spark Igniter
- 36" Ground Lead
- Mounting Hardware (Screw, Flat Washer, and Nut)

Necessary Tools:

- Adjustable Wrench or Pliers
- Screw Driver



Instructions:

1. Locate and remove blank mounting plate from burner pan by unscrewing stainless steel nuts and bolts.
2. Using the new mounting plate provided with your burner pan, insert the Spark Igniter Probe lead through the center hole, aligning the outer holes with the Spark Igniter Probe mounting hole and ground post.
3. Insert the mounting screw through the mounting hole. From the bottom of the fire feature, attach the flat washer terminal and tighten the nut beneath the flat washer terminal, securing the ground wire to the igniter base.
4. Attach both Spark Igniter Probe lead and ground wire lead to the back of the Push Button Spark Generator. Be sure both of the available terminals are occupied. There is no specific order.
5. Mount the Push-Button Spark Generator to the outside of the fire feature with a custom mounting plate. We also have a generic version of the mounting plate available for purchase.
6. To mount the Push Button Spark Generator our plate, start by removing rubber push button assembly and lock ring. Insert the threaded portion of the battery cavity through the $\frac{3}{4}$ " hole in the mounting plate, then use the locking ring to secure the spark generator to the mounting plate. Finally, mount the plate and spark generator assembly to an opening made in the enclosure wall.
7. Unscrew rubber push button assembly exposing the battery cavity. Insert 'AAA' battery with negative side facing in. Replace rubber push button.

WARRANTY ADJUSTMENT:

1. AMERICAN FIRE PRODUCTS agrees to repair or furnish a replacement for, but not remove or install any product or component, which proves defective, within the above warranty and appropriate time periods stated
2. BUYER shall notify AMERICAN FIRE PRODUCTS of any defect within this warranty no later the thirty (30) days after a defect is discovered.
3. No product will be accepted for return or replacement without authorization by AMERICAN FIRE PRODUCTS. Merchandise returned without proof of purchase date will be serviced out of warranty at our prevailing service and part rates.
