
## Assembly Preparation

- Read instructions, cover to cover-
- Have 2 adults on hand for assembly-
- Do not assemble on flooring or carpet-
- Assemble on a clean non-marring surface (packing foam)-
- Save all packaging until finished-


## Assembly Steps

### Overview



This double sofa has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Single Chair parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

## Step 1



Open the carton and place all the parts onto a clean, non-marring surface.

Place the Seat(A) facedown.

1.1 Attach Leg(B) to Seat(A) using bolts(1) and washer (4) with Allen wrench(5) as shown above.

Do not fully tighten the bolts.

Place the double sofa on a LEVEL SURFACE.

Inspect it and make sure all Leg are adequately connected.

Gently and carefully press onto the sofa with both your hands, this will help to align all parts at all joints.


Then get off the sofa, and in a sequential manner, proceed to tighten all bolts.

When tightening the bolts, tighten sequentially.

Do not tighten any Bolt fully and then move on to the next one, this may cause the frame to warp. If there are still wobbles, loosen the bolts and execute this same process.

Note: This step is done best with the assistance of a second adult.

## Step 2




Place the Seat(A) facedown.

Step 2.1: Attach Seat(A) to Middle Leg(C) using bolts(1) and washer(4) with Allen wrench(5) as shown above.


Do not fully tighten the bolts.

### Step3



Insert Backrest(D)to Seat(A)as show above  
Attach Backrest(D)to Seat(A)using bolts(②)and washer (③)with Allen wrench(⑤)as shown above.  
Tighten the bolts

### Step4



Stand the double sofa up.  
Put Back Cushion(F) and Seat Cushion(E) on the double sofa, and stick the magic tape.  
Your double sofa is ready for use.  
Place the double sofa on a **LEVEL SURFACE**.  
Inspect it and make sure all parts are adequately connected.  
Gently and carefully sit onto the double sofa.  
This will help to align all parts at all joints.  
Then get off the double sofa, and in a sequential manner, proceed to tighten all bolts.  
When tightening the bolts, tighten sequentially.  
**DO NOT** tighten any Bolt fully and then move on to the next one.  
This may cause the frame to warp.  
If there are still wobbles, loosen the bolts and execute this same process.  
Note: This step is done best with the assistance of a second adult.  
Your double sofa is ready for use.  
This double sofa can only be used on a flat, level surface.




# Assembly Steps

## Overview



This corner seat has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the corner seat parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

## Step 1



Open the carton and place all the parts onto a clean, non-marring surface.

Place the Seat (A) facedown.

1.1 Attach each Leg (B) to the Seat (A) with Bolts (1) and washers (4), using the Allen wrench (5) as shown above.

Do not fully tighten the Bolts.

Place the Corner seat on a LEVEL SURFACE.

Inspect it and make sure all Legs are adequately connected.

Gently and carefully sit on the Corner Seat, as this will help align all parts at all the joints.

Then get off the seat, and in a sequential manner, proceed to tighten all Bolts.


When tightening the Bolts, tighten sequentially.

DO NOT tighten any Bolt fully and then move on to the next one, as this may cause the frame to warp.

If it wobbles after tightening, loosen the Bolts and execute the same process again.

Note: This step is done best with the assistance of a second adult.

## Step 2




Insert the Backrest (C) to the Seat (A) as shown above.

Attach the Backrest (C) to the Seat (A) with Bolts (2) and washers (3), using the Allen wrench (5) as shown above.


Tighten the Bolts.

### Step3



Put Seat Cushion(D) and Back Cushion(E) and Small Back Cushion (F) on the Corner Seat. It is now ready for use.

### Additional Hardware:



To connect all corner seat sections:

Remove all cushions. Use the connecting piece(6) to connect the corner seat sections together as shown in the picture.

Put all cushions back on the corner seat.

Your corner seat ready for use.

This corner seat can only be used on a flat, level surface.

## Step 1




Open the carton and place all the parts onto a clean, non-marring surface.

Place the Table Top(A) facedown.

1.1 Attach each Leg(B) to the Table Top(A) with Bolts(①) and washers (②), using the Allen wrench(③), as shown above.

Do not fully tighten the Bolts.

## Step2



Turn the table upright and place on a level surface .

Inspect it and make sure all legs are adequately connected.

Gently and carefully press onto the table with both your hands, as this will help align all parts at all the joints.

Then in a sequential manner, proceed to tighten all bolts.

When tightening the bolts, tighten sequentially.

Do not tighten any bolt fully and then move on to the next one, as this may cause unevenness.

If the table wobbles after tightening the bolts, loosen the bolts and execute the same process again.

Note: This step is done best with the assistance of a second adult.

Your table is now ready for use.

This table can only be used on a flat, level surface.
