WHO AND WHAT ARE COVERED AND FOR HOW LONG?

CertainTeed Gypsum, Inc.
("CertainTeed") warrants to the
Original Owner that its Marco" tape
products ("Tape Products") will be
free from manufacturing defects for
one (1) year from the date of
purchase if installed in accordance
with CertainTeed's applicable
installation guide. Should CertainTeed
determine that a Tape Product
contains a manufacturing defect,
CertainTeed, at its sole discretion, will
provide replacement Tape Product or
refund the original purchase price of
the defective product.

TRANSFER ABILITY

The coverage under this limited warranty is not transferable or assignable.

WHAT THE ORIGINAL OWNER MUST DO

To obtain performance under this limited warranty, the Original Owner (original purchaser at retail) must notify CertainTeed within thirty (30) days of discovery of a claimed manufacturing defect, but such notice must be within one (1) year from the original date of purchase. The Original Owner must submit with such notice, proof of date of purchase and installation in order to provide CertainTeed an opportunity to investigate the claim and examine the Tape Product claimed to be defective. Notification must be provided to:

CertainTeed will review the claimed defect and may request samples or access to the property where the Tape Products are installed.

LIMITATIONS

This limited warranty does not provide protection against, and CertainTeed will have no liability for, any failure, defect or damage of the Tape Products caused by events beyond its control, including but not limited to:

- Installation and finishing practices not in accordance with CertainTeed's published installation instructions.
- Failure of or defects in materials to which the Tape Products are attached or which are attached to it. This includes any damage to the Tape Products resulting from the installation, repair or removal of any materials installed over, adjacent to, or attached to the Tape Products.
- Failure of the owner to maintain the residence or building with reasonable care and to protect the Tape Products from being subjected to more than normal use and exposure within the building.
- Claims related to mold, mildew, algae, fungus, bacteria or other conditions involving organic growth.

- Failure to install the Tape Products within one (1) year from its date of shipment.
- Any acts, omissions, or negligence of the Original Owner or any third party.
- Damage due to improper building or system design.
- Damage or abuse caused by improper transport, handling, or storage not in accordance with standard building practices and applicable building codes.
