### DIRECTIONS FOR USE: SHAKE WELL BEFORE EACH USE.

**HOSE END SPRAYER:** Make sure the handle control lever is in the OFF position. The handle control lever should be at a 90° angle and in the lock tab. Attach threaded end with washer to the hose. Turn on faucet, aim the nozzle toward area to be sprayed - bend tab back then TURN the handle control lever on by turning it clockwise (handle control lever should be at a 45° angle) to begin spraying the product. **When finished application:** Bend tab back - turn the handle control lever counter clockwise to the OFF position (handle control lever should be back at a 90° angle). Turn off faucet. Bend tab back and turn handle control lever on to discharge residual water pressure. Store with the control lever in the locked position. **Repeat application every few days if needed.**

**NOTE:** Make sure to spray branches and the underside of leaves until the plants are dripping. Please spray early in the morning or after 4:00 PM to avoid any leaf burning.

**PRECAUTIONARY STATEMENTS: CAUTION: KEEP OUT OF REACH OF CHILDREN.** Avoid contact with skin, eyes or clothing. Do not swallow. Wash thoroughly with soap and water after handling. Do not apply directly to water.
