






Before beginning the assembly process, ensure all boxes and parts have been delivered.

- Proper assembly requires two people.
















Attach the END SIDE (D and E) to the MIDDLE(C), slide the PLASTIC CONNECTIONS to the grooves.






◆Attach the two CONNECTING TUBES (R) to the UPRIGHT (F and G) by using eight BOLTS (2).










♦Insert four WOOD DOWELS (5) to the MIDDLE (C).






◆Fasten the two CONNECTING TUBES (R) to the MIDDLE (C) by using four BOLTS (3).






♦Insert eight WOOD DOWELS (5) to the BOTTOM (B).


- Attach the BOTTOM (B) to the ENDS (D and E) and the UPRIGHTS (F and G), fasten the BOTTOM (B) by using eight BOLTS (1).
- ♦You should start each BOLT a few turns before completely tightening any of them.







♦Insert eight WOOD DOWELS (5) to the TOP (A) and MIDDLE (C).

Attach the TOP (A) to the ENDS (D and E), the MIDDLE UPRIGHT (H), and the BACK UPRIGHTS (S), tighten eight PLASTIC CAM LOCKS.




- ◆Fasten BACK (J) to the MIDDLE (C), the ENDS (D and E), the UPRIGHTS (F and G) and the BOTTOM (B) by using eighteen BOLTS (1).
- ◆You should start each BOLT a few turns before completely tightening any of them.







- ◆ Fasten the LEGS (Q) to the BOTTOM (B) by using twenty four BOLTS (2).
- ◆ Plug in two GROMMET (7) to the BACK (J).








Attach the DRAWER SIDES (L and M) to the DRAWER FRONT (K), slide the PLASTIC CONNECTIONS to the grooves.




◆Slot the DRAWER BOTTOM SUPPORT (P) to the DRAWER FRONT (K).






Slide the DRAWER BOTTOM (O) into the grooves, in the DRAWER SIDES (M and L), and the DRAWER FRONT (K).



Fasten the DRAWER BACK (N) to the DRAWER SIDES (L and M) and the DRAWER BOTTOM SUPPORT (P) by using six BOLTS (1).






◆Use two BOLTS (2) to fasten the PULL (4) to the DRAWER FRONT (K). Repeat the same on the other drawers.




To insert the DRAWER into your unit, line up the EXTENSION SLIDES on the drawer with the EXTENSION RAILS on the unit and push the drawer into the unit.


Before the drawer is fully inserted, please make sure the interlock pins on the EXTENSION SLIDES on the drawer is pushed forward as shown on the diagram. The drawer should push in hard until it is all the way in , then it will slide in and out easier.

Attention: This unit used Drawer Interlocking System, when one drawer is open, the other drawers cannot be opened.



Insert the METAL PINS (6) into the hole location of your choice in the ENDS (D and E) and UPRIGHTS (Fand G) Set The ADJUSTABLE SHELVES (I) onto the METAL PINS. (2 PCS)
