- 2. Wipe using a soft clean towel or microfiber cloth.
- 3. In the case of tough dirt, allow the product to stand for several minutes before wiping. Cleaning may require scrubbing with a white nylon pad.

Close the container tightly after each use. Store in the original container only. Store between temperatures of 35°F to 90°F (2°C to 32°C). Do not allow to freeze.
