



STAINMASTER® LVT Premium Underlayment Limited Lifetime Warranty

The manufacturer warrants that its Stainmaster LVT premium underlayment will conform to the published product specifications and is free from defects in manufacturing, materials and workmanship for the life of the original residential homeowner (the "Limited Warranty Period.") (The Product) subject to manufacturing tolerances, will be merchandisable for the ordinary purpose for which the goods are designed. This underlayment is for floating click lock luxury vinyl planks 3.2mm plank thickness. All installations must be conducted in strict accordance with the installation instructions provided and the installation instruction provided by the flooring manufacturer, which includes acceptable subfloor types, flatness, moisture/temperature, expansion requirements and limitations. In addition this product should not be used over existing vinyl without the use of an approved 6 mil moisture barrier. This warranty is null and void if the product has been punctured, penetrated, ripped or torn during or before installation.

This warranty will only be effective if the Stainmaster LVT premium underlayment is installed and maintained in full compliance with the manufacturer's instructions, recommendations and specifications. The manufacturer is not responsible or liable for faulty installations procedures inconsistent with the flooring manufacturer's installation instructions and maintenance procedures. Vinyl flooring product shrinkage and expansion cannot be controlled by the manufacturer Stainmaster LVT premium underlayment and should shrinkage or expansion occur to the flooring the manufacturer is not responsible.

EXCLUSIONS TO THIS WARRANTY

- Standing water pre-existent to the installation or post installation.
- Moisture in the slab exceeding the ranges previously specified in this document or the manufacturer's installation instructions.
- Failures or damages resulting from installation error or neglect.
- Unlevel subfloors not addressed per the manufacturer's installation instructions.
- Hydrostatic water pressure.
- Atmospheric conditions found to be outside of the manufacturers tolerances including but not limited to excessive high or low air temperature and humidity.
- Failure to follow the manufacturer's Stainmaster LVT installation instructions.
- Failure to follow the flooring manufacturer's installation instructions.
- Abuse, misuse and defects to the vinyl flooring.
- Any outdoor installations.

CONDITIONS AND EXCLUSIONS TO THIS LIMITED LIFETIME WARRANTY

IN THE EVENT OF A DEFECT, MALFUNCTION OR OTHER FAILURE OF THE PRODUCT (NOT OTHERWISE EXCLUDED ABOVE.) THE MANUFACTURE WILL REMEDY THE DEFECT UPON PHYSICAL INSPECTION OF THE FLOORS SHOULD IT BE DETERMINED THAT THE STAINMASTER LVT PREMIUM UNDERLAYMENT WAS THE SOLE CAUSE OF THE FAILURE. IN THAT EVENT, THE MANUFACTURER MAY REPLACE, REPAIR OR REFUND THE DAMAGED LVT/VINYL PLANKING IN THE EFFECTED AREA TO WHICH THE STAINMASTER LVT PREMIUM UNDERLAYMENT WAS ORIGINALLY INSTALLED. THIS INCLUDES REASONABLE REPLACEMENT LABOR COSTS RESULTING FROM A DEFECT IN STAINMASTER SOLEY ATTRIBUTED TO A MANUFACTURING DEFECT AND NOT A DEFECT AS A RESULT OF FAULTY OR CARELESS INSTALLATION PROCEDURES. THIS EXCLUSIVE AND LIMITED WARRANTY WILL BE EFFECTIVE ONLY IF THE STAINMASTER LVT UNDERLAYMENT WAS INSTALLED AND MAINTAINED IN FULL COMPLIANCE TO THIS LIMITED WARRANTY AND THE WARRANTY AS SPECIFIED IN THE FLOORING MANUFACTURER INSTRUCTIONS, RECOMMENDATIONS AND SPECIFICATIONS. THE MANUFACTURER RESERVES THE RIGHT TO CONDUCT AN INDEPENDENT INSPECTION OF THE INSTALLATION TO DETERMINE THE CAUSES OF ANY ALLEGED FAILURES. ALL ORIGINAL RECEIPTS OF PURCHASE OF THE FLOORING PLUS MANUFACTURERS INSTALLATION INSTRUCTIONS MUST BE AVAILABLE TO THE INSPECTOR UPON INSPECTION OR PRIOR TO INSPECTION.
