Please look in boxes for hardware packs and legs. Sets often ship in multiple boxes and may arrive a day or two apart.





Do not assemble on flooring or carpet-




Assemble on a clean non-marring surface (packing foam)-



Assembly Steps



This Barstool has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Barstool parts, the above picture is provided to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.




Open the carton, and place all parts on a clean, non-marring surface.

Attach the Upper Cross (C) to Left Front Leg (E) and Right Back Leg (G), using Cam Lock (⑤) and Bolts (⑥) with Allen Wrench (⑦) as shown above.


Make sure the exposed indentation of the Cam Lock (⑤) is parallel to the wooden block when attach them.

Do Not Fully Tighten the Bolts.




Repeat Step 1, and assemble the Lower Cross (I) to the Left Back Leg (F) and Right Front Leg (E).

Do Not Fully Tighten the Bolts.




Attach the assembled legs together as shown above.



Turn over the Leg Frame of Step 3 as shown above.


Attach the Front Pedal / Back Pedal (C) to the Legs using Bolts (4) with Allen Wrench (7).

Do Not Fully Tighten the Bolts.




Attach the Left Pedal / Right Pedal (D) to the Legs using Bolts (4) with Allen Wrench (7) as shown above.

Do Not Fully Tighten the Bolts.



Attach the assembled frame of Step 6 to Seat (B) using Bolt (②) and Flat Washer(⑥) with Allen Wrench(⑦) as shown above.


Do Not Fully Tighten the Bolts.



Attach the Backrest (B) to the Left Back Leg (F) & Right Back Leg (G), using Bolts (③ & ④) and Flat Washer (⑥) with Allen Wrench (⑦).

Do Not Fully Tighten the Bolts.





Stand the Barstool side up, and place it on a LEVEL SURFACE.

Inspect it and make sure all parts are adequately connected.

Gently and carefully tap the seat and check for wobbleness, then tighten all bolts in a asequential manner.

If there is still wobbling, loosen the bolts and repeat the same process untill all the Bolts are Fully Tighten.

Your Barstool is ready for use.

This Barstool can only be used on a flat, level surface.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals. By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
