### 4. First-aid Measures

**FIRST AID - EYE CONTACT:** Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed.

**FIRST AID - SKIN CONTACT:** Wash skin with soap and water. Remove contaminated clothing. Get medical attention if irritation develops or persists.

**FIRST AID - INHALATION:** Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get immediate medical attention. ### 5. Fire-fighting Measures

**UNUSUAL FIRE AND EXPLOSION HAZARDS:** No unusual fire or explosion hazards noted. Keep containers tightly closed. FLASH POINT IS TESTED TO BE GREATER THAN 200 DEGREES F.

**SPECIAL FIREFIGHTING PROCEDURES:** If water is used, fog nozzles are preferred. Water may be used to cool closed containers to prevent buildup of steam.

### 6. Accidental Release Measures

**STEPS TO BE TAKEN IF MATERIAL IS RELEASED OR SPILLED:** Dispose of according to local, state (provincial) and federal regulations. Do not incinerate closed containers. Sweep up gently to avoid dust cloud formation.

### 7. Handling and Storage

Follow all MSDS/label precautions even after container is emptied because it may retain product residues. Avoid breathing fumes, vapors, or mist. Avoid contact with eyes, skin and clothing.

### PERSONAL PROTECTION
