4. First-aid Measures

Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of carbon black in the formula. Reports have associated repeated and prolonged occupational overexposure to solvents with permanent brain and nervous system damage. May cause central nervous system disorder (e.g., narcosis involving a loss of coordination, weakness, fatigue, mental confusion, and blurred vision) and/or damage.
