




 \ast Insert Sixteen KD BOLT (1) to the BACK STRIP (G) .





* Attach the BACK STRIP (G) to the LEFT PANEL (C) and RIGHT PANEL (D) by the Eight KD CAM (2) , Eight COVER CAP (3) , and Six WOOD DOWEL (4) .




Step 3:

* Insert Eight KD BOLT (1) to the LEFT PANEL (C) and RIGHT PANEL (D).






* Attach the LEFT BACK PANE (E) and RIGHT BACK PANEL(F) by the Four WOOD DOWEL (4) .












* Attach the TOP (A) and BOTTOM (B) to the ASSEMBLY by the Eight KD CAM (2) , Eight COVER CAP (3) ,and Four WOOD DOWEL (4) .




* Attach the LEFT PANEL (C) and RIGHT PANEL (D) to the ASSEMBLY by the Sixteen KD CAM (2) , Sixteen COVER CAP (3), Fourteen WOOD DOWEL (4) .




* Attach the LEGS (7) to the ASSEMBLY by the BOLT (10).






* Use LOCK (5) tighten all Bolts .




*As shown in the picture: Insert ten SHELF PEGS (6) into the side panel and place the SHELF PANEL (H) diagonally inside



* Insert the SHELF PANEL (H) diagonally into it and then insert 2pcs SHELF PEGS (6)




* Attach HINGE (8) and SCREW (9) to the LEFT DOOR (I) and RIGHT DOOR (J).




* Carefully stand your unit upright.

Fasten the LEFT DOOR (I) and RIGHT DOOR (J) to the LEFT PANEL (C) and RIGHT PANEL (D).

* Note : The hinges should be hooked first from the top to the middle and lower hinge combinations in the "PRESS" order . Note that the hinge leaf must be inserted into the slot along the angle.



* Attach anti-tipping straps to the back of the stand.



Step 15:


1st- With your pencil, strike a mark through the center of the hole in the SAFETY STRAP.

2nd- Drill a 3/8" hole on the mark.

3rd- FURNITURE TIPPING RESTRAINT KIT (15) into the hole until it is even with the surface of the wall.

4th- Turn the LONG SCREW through the hole in the SAFETY STRAP and into the WALL ANCHOR.

NOTE: You will need to turn the LONG SCREW multiple turns to completely tighten and secure your unit.







* Insert Fourteen KD BOLT (1) to the BACK LEFT STRIP (K) and BACK RIGHT STRIP (L).




- * Attach the BACK LEFT STRIP (K) to the LEFT PANEL (C) by the Three KD CAM (2), Three COVER CAP (3), and Two WOOD DOWEL (4).
- * Attach the BACK RIGHT STRIP (L) to the RIGHT PANEL (D) by the Three KD CAM (2), Three COVER CAP (3), and Two WOOD DOWEL (4).




* Insert Eight KD BOLT (1) to the LEFT PANEL (C) and RIGHT PANEL (D).



* Insert Twelve KD BOLT (1) to the TOP (A) , BOTTOM (B) ,TOP BACK PANEL (F) and BOTTOM BACK PANEL (G).



* Attach the BOTTOM (B) to the BOTTOM BACK PANEL (G) by the Four KD CAM (2) , Four COVER CAP (3) ,and Two WOOD DOWEL (4) .





* Insert Sixteen SHELF PEGS (6) into the Sideboard and put on the Two SHELF PANEL (H) .










* Attach HINGE (7) and SCREW (9) to the DOOR (I) and DOOR (J) .




* Carefully stand your unit upright. Fasten the DOOR (I) and DOOR (J) to the MEDIAN PANEL (E)

* Note : The hinges should be hooked first from the top to the middle and lower hinge combinations in the "PRESS" order . Note that the hinge leaf must be inserted into the slot along the angle.



* Attach anti-tipping straps to the back of the stand.



Step 19:


1st- With your pencil, strike a mark through the center of the hole in the SAFETY STRAP.

2nd- Drill a 3/8" hole on the mark.

3rd- FURNITURE TIPPING RESTRAINT KIT (15) into the hole until it is even with the surface of the wall.

4th- Turn the LONG SCREW through the hole in the SAFETY STRAP and into the WALL ANCHOR.

NOTE: You will need to turn the LONG SCREW multiple turns to completely tighten and secure your unit. $Q = \frac{1}{2}$
