

# BowerUSA Warranty

Your Bower Products are covered by a limited product warranty (Limited Warranty) for the 1-year period following the original date of purchase (Warranty Period). If a substantial defect in material or workmanship arises with your Bower Product, and a valid warranty claim is received by Bower within the Warranty Period, you will be entitled to a replacement of the product purchased or a similar product (depending on availability).

This Limited Warranty is non-transferable and covers only the original end purchaser of the applicable Bower Product. Proof of purchase in the form of the original purchase receipt or packaging slip is required for warranty validation and service. Warranty claims must be made directly to Bower. Bower reserves the right to inspect the product and determine whether it is defective in materials or workmanship. If we find that the product is defective, we shall at no charge to you replace the product at our discretion, and return the product to you. You are responsible for shipping costs to Bower but there is no charge for the inspection or the return postage within the United States. This warranty does not cover damages resulting from accidental drops, misuse, abuse, tampering, modification, or breakage due to improper care.

Bower is not responsible for damages resulting from any breach of warranty including but not limited to loss of use, loss of revenue, and loss of anticipated profits. BOWER warranties do not cover any third party devices or the personal property of any consumer (includes cameras, lenses, smartphones, tablets & computers). Any alteration, change, modification, or repair (other than replacement of a replaceable component) made to the product by a party other than Bower will void this warranty.

BOWER WARRANTIES AND REMEDIES SET FORTH ABOVE ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, REMEDIES AND CONDITIONS, WHETHER ORAL OR WRITTEN, EXPRESS OR IMPLIED. The Limited Warranty does not extend to or otherwise apply to any non- Bower Product This Limited Warranty applies only to the normal use of the covered Bower Product, normal wear and tear excepted, in accordance with the written use instructions provided with the Bower Product. This Limited Warranty does not apply to damage to the Bower Product caused by accident, abuse, misuse, use for any purpose other than its intended purpose, acts of God, or any alteration or modification of the Bower Product.
