


Assembly Instructions

The 2700 Fabric Door Canopy

Hardware Pack

The 2700 series Fabric Door Canopy comes packaged in two separate plastic bags one with the hardware & instructions and in the other the Canopy with three frame pieces, a Mounting Bar, Top Trim & Front Trim - (for your convenience the Front Trim & Top Trim frame parts are already attached to the Canopy).


The 2700 Door Canopy will come rolled with the top or outside rolled to the inside. Unroll the Canopy, {The **Mounting Bar**, rolled inside the Canopy will be used in Step 1 of the installation instructions, set it aside for now}. Open the sides, then flip the whole Canopy over. The Canopy will be assembled from this position, **upside** (or topside) **down** and inside or underside UP. Notice, as mentioned above, the top trim and front trim frame pieces are already attached.

Support Arm

Camel Back Wall Bracket

Edge Canopy Rafter



Begin by attaching one end of one of the **Support Arms** to the **Edge Canopy Rafter** by inserting it into the Camel Back Wall Bracket that is already mounted on the Edge Canopy Rafter using a machine screw.

Note: Insert the machine screws through the **Camel Back Wall Bracket** and the Support Arms from the *outside in* toward the Canopy.

Attach one **Edge Canopy Rafter** to the **Front Trim** using small screws in pre-punched holes - the Front Trim is behind the Valance on the inside of the Canopy and is pre-attached.

Note: Be sure to position the Edge Canopy Rafters so that the ends with the attached Camel Back Wall Bracket / Support Arm is toward the outside and at the front of the Canopy (Front Trim).


Front Trim

Edge Canopy Rafter



Attach the other end of the **Edge Canopy Rafter** to the **Top Trim** on both sides using two small screws in pre-punched holes.

Repeat steps 3,4 & 5 for the second Support Arm and secure the other Edge Canopy Rafter on the other side of the Canopy.




Position the **Center Rafter** in the center of the Canopy and align with pre-punched holes at the front trim & the top trim. Then, fasten the Center Rafter to the *Front Trim 1st* and then the **Top Trim** with two small screws at each end. (as shown in Step 6 details)

Picture Inserts: The Fabric Canopy is turned vertically to show placement of Center Rafter with attachment details to the Front Trim & Top Trim.

The 2700 Series Door Canopy is now ready for installation.



Installation Instructions




Install Mounting Bar with large screws 13" above the door.

Be sure the bar is level and centered over the door opening. Screws must be in studs or heavy sheathing. (Drill alternate holes in bar if necessary)

Please refer to Step 1 - Detail to place the Mounting Bar correctly on the wall.



Caulk the top of the mounting bar against the house.



Flip the Canopy over to its installed position (as shown above) then lift the Canopy up and angle the Top Trim insert into the Mounting Bar and let it down slowly. It will rest here locked in place while you secure it. Please refer to Step 2 - Detail for cross section diagram.

Secure the Mounting Bar & the Top Trim together with small screws in pre-punched holes from underneath.




Apply a bead of caulking in the trough of the mounting bar prior to the awning's top trim placement into the mounting bar.

(Front) - Awning Frame Views - (Side)



Attach the (2) two loose Camel Back Wall Brackets, temporarily, to the other end of the Support Arms using a machine screws.

Before securing Support Arms with Camel Back Wall Brackets to your house please refer to the mounting chart here for model number and correct mounting points for your Awning.

Note: Mounting dimension 'A' is measured from the top of the Mounting Bar to the center of the Camel Back Wall Bracket -shown at left.

Now attach mounting brackets to the house using large screws making sure the Camel Back Wall Brackets are secured in solid sheathing at the proper points from the reference chart.





After Camel Back Wall Brackets have been secured to the house, remove the machine screws and re-insert them through grommeted tabs on your awning to secure the Canopy sides and screw them back into the camel back wall brackets.

Installation is now complete.

Additional Instructions for Oversized Canopy / Awning



Oversized awning above is shown 'UP-SIDE DOWN' to illustrate additional support arm placement

Custom oversized Canopy / Awnings are generally the same as an in-stock Canopy / Awning. The instructions will be mostly the same except for added Support Arm Sets to carry the weight evenly over the width of the Canopy / Awning.

Additional Center Rafters, Camel Back Wall Brackets and Support Arm Sets have been supplied.

Please refer to assembly instructions (Steps 3,4 & 5) in this booklet, if necessary, to assemble these additional Center Rafter/Mounting Bracket/Support Arm Sets.

The appropriately sized Mounting Bar has also been supplied, please refer to installation instructions in this booklet (Steps 1 & 2) for proper installation of the Mounting Bar. Follow all other instructions for assembly and installation.
