










Attach the parts 03-04 to part 05 with hardware B. Then, fix them with screw H.






















Then, apply the hardware F and lock it according the example below.















Fix screw K on parts 01-03-04.






















Specially to part 08, fix the part 15 with screw G.

Then fix the intermediate screws.








The sides of the drawers have pre-defined holes to help with fixing.

with the pre-defined holo on the drawer side. Then fix them with screw K.








Attach the parts 08 to parts 11-12 with hardware B.

Then, apply the hardware F and lock it according the example below.


Equaly, the same process is apllied to parts 09-11-12.









Attach the part 10to parts 11-12-14 with the hardware B. Then, fix the parts 11-12 to part 10 with screw A.








Firstly, keep the drawer partially open so that the limiter screw hole is behind the limiter bracket according to the detail.






ATTENTION: ensure the limiter screw hole is before the limiter bracket.

Then, place the screw #PA.010 to retain the full opening of the drawer.





Apply the same process to drawer opening limiter to the others drawers.








You must install the Tipover Restraint Kit (J) provided, in the rear side of the furniture. Position the hardwares #18256EXP and #20522.


Fix them with screw #11179.

Then, mark with a pencil where you should drill the wall to put in the hardware.






Put in the hardware #16973 to the hole that you drilled on the wall.
