## **General Application Instructions:**

- Please allow DayGlo Screamin' Fluorescent Paints undercoat to dry for at least 24 hours before applying DayGlo Filteray® W Clear Overcoat.
- 2. Apply one moderate coat of DayGlo Filteray® W Clear Overcoat. Thin only if necessary, using water.
- 3. Allow 2 hours to dry before putting into service.
- 4. Clean brushes should always be used. After use, they can be cleaned up with warm water.
- Application of DayGlo Filteray® W Clear Overcoat will cause the color to deepen. It will have a glossy finish.
   Fluorescent surfaces coated with DayGlo Filteray® W will not fluoresce in the dark under black light.
- DayGlo Screamin' Fluorescent Paints and DayGlo Filteray®
  W Clear Overcoat may be applied with a spray gun. Stir well and thin to spraying consistency using water, then strain.
- The normal shelf life of DayGlo Screamin' Fluorescent Paints and DayGlo Filteray® W Clear Overcoat is 1 year in unopened cans. These products should be stirred before use.
- Avoid freezing and close can tightly when not in use. Use with adequate ventilation.
