



### **Olefin Outdoor Cushion Fabric Limited Warranty**

Brentwood Originals, Inc. ("Brentwood") provides limited warranty coverage to purchasers of its Olefin fabrics. Limited warranty coverage applies only to the fabrics and not any furniture constructions for which the fabrics may be used to make cushions.

Brentwood warrants its fabric will be resistant to premature color fading during the limited warranty period from date of purchase. Coverage is limited to 3 years from date of purchase for Olefin fabrics. No limited warranty coverage applies to normal wear and tear, mildew, punctures, cuts, tears or rips, seam separation, harsh solvents or chemicals, or misuse of the fabrics. Proof of purchase is required to obtain coverage under this Limited Warranty, and no warranty coverage is provided without proof of purchase.

This Limited Warranty is the sole and exclusive warranty provided by Brentwood. Any and all other warranties and conditions are excluded and disclaimed. **UNDER THE LAW OF CERTAIN STATES, THERE MAY BE NO IMPLIED CONDITIONS OR WARRANTIES FROM BRENTWOOD APPLICABLE TO YOUR PRODUCT, AND ALL IMPLIED CONDITIONS OR WARRANTIES (INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE) ARE EXCLUDED AND DISCLAIMED WHERE ALLOWED BY LAW.** If implied warranties are imposed under any applicable state law, all such implied warranties are limited to the duration of the applicable provisions of this Limited Warranty. If a defect covered by this warranty occurs, Brentwood will refund the purchase price. Refund is the **sole and exclusive remedy** under this Limited Warranty.
