




# STOP!

\* Insert Nine KD BOLT (1) to the TOP PANEL (A)




<sup>\*</sup> Insert fourteen KD BOLT (1) to the LEFT FRAME (C) and RIGHT FRAME (D)


## Step 3:


\* Install module at step 4 and module at step 7 by the seven KD LARGE CAM (2), seven COVER CAP (3) and six WOOD DOWEL (4)






\* Insert the UPPER BACK PANEL (F) to the stand.



\* Insert Two KD BOLT (1) to the FRONT LOWER PANEL (I) & BACK LOWER PANEL (J)






\* Insert two L BRACKET (21) to the FRONT LOWER PANEL (I) by the four SCRFW (22)




### Step 17:

\* Slide in the DRAWER BOTTOM PANEL (P)





\* Assemble the DRAWER SUPPORT PANEL (Q) to the DRAWER TRAY by the SCREW (8)












- \* Attach six BLACK HANDLE (11) or six GOLD HANDLE (12) to three DRAWER LEFT FRONT PANEL (R) and three DRAWER RIGHT FRONT PANEL (S) by twelve SCREW (10)




### Step 21:

\* Assemble the three DRAWER LEFT FRONT PANEL (R) and three DRAWER RIGHT FRONT PANEL (S) to the DRAWER TRAY by the thirty KD SMALL CAM (6) and thirty COVER CAP (3)








### Step 23:


\* Insert eight PLASTIC WEDGE (13) to the UPPER BACK PANEL (F) by the eight SCREW (9)

#### Step 25:


1st- With your pencil, strike a mark through the center of the hole in the SAFETY STRAP.

2nd- Drill a 3/8" hole on the mark.

3rd- FURNITURE TIPPING RESTRAINT KIT (16) into the hole until it is even with the surface of the wall.

4th- Turn the LONG SCREW through the hole in the SAFETY STRAP and into the WALL ANCHOR.

NOTE: You will need to turn the LONG SCREW multiple turns to completely tighten
