PRODUCT INFORMATION

Through a single mosquito bite, adult mosquitoes can pose a serious threat to people and animals by transmitting Zika, West Nile Virus, St. Louis Encephalitis, Dengue, or Chikungunya.
This product is a patented, bi-layer tablet for use in mosquito breeding sites. The white layer quickly releases a dose of active ingredient that provides rapid control of existing mosquito larvae. The tan layer provides a slow release of active ingredient that continually controls mosquitoes in the water for up to 60 days. This product's active ingredient, spinosad, is biologically derived from the fermentation of *Saccharopolyspora spinosa*, a naturally occurring soil organism.

APPLICATION DIRECTIONS

This product can be used in artificial containers and natural standing-water sites around your home to control the mosquito larvae of breeding mosquitoes. This product can be applied as a preventative action (pre-flood treatment) before sites fill with water. This product may also be used in sites that intermittently fill with water; the BioAdvanced Science-Based Solutions Mosquito Killer FizzTabs slow release layer will stop working when dry, and begin working again when re-wetted. This product will control mosquito larvae for up to 60 days when immersed in water. Reapply after 60 days as needed.

RESTRICTIONS

Do not apply to natural or artificial containers of water intended for consumption by people, animals, or livestock.
In New York State, this product is only for use in containerized sites with no outflow to the natural environment.

APPLICATION SITES

Bird Baths, Ornamental Fish Ponds, Garden Ponds, Containerized Water Gardens, Ornamental Fountains, Ornamental Pools or Ponds, Flower Pots or Planters, Rain Barrels, Urns, Tree Holes, Pool Covers, Unused or Abandoned Swimming Pools, Roof Gutters, Roof Top Catchments, Storage Tanks, Drums, Buckets, Wheelbarrows, Garbage Cans, Other Water- Holding Receptacles, Floor Drains, Old Tires, Rock Holes, Pot Holes, Tire Tracks, Other Natural and Man-Made Depressions

APPLICATION RATES

One tablet treats up to 50 gallons for up to 60 days.
For shallow standing water holding areas (less than 8 inches deep), one tablet treats up to 10 square feet of surface area.
For shallow standing water holding areas (less than 4 inches deep), one tablet treats up to 20 square feet of surface area.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.
Pesticide Storage: Store in a cool dry place in original container only.
