# **EMERGENCY OVERVIEW**

May cause mild transient eye irritation. Prolonged skin contact may cause irritation. Oil injection into the skin from high-pressure hydraulic systems may cause severe injury. #### 4. First Aid Measures

INHALATION: If symptoms of exposure develop, remove to fresh air. If breathing becomes difficult, administer oxygen. Administer artificial respiration if breathing has stopped. Seek immediate medical attention.

NOTES TO PHYSICIAN: There is no specific antidote. The petroleum oil and other ingredients in this product are unlikely to produce systemic symptoms following accidental ingestion. Upon ingestion, there is a slight risk of aspiration in the lungs which can lead to pneumonitis and non-cardiogenic pulmonary edema. Do not induce vomiting. If aspiration is suspected the patient should be observed for sign of lung injury. Treatment should be directed at the control of symptoms and clinical conditions.
