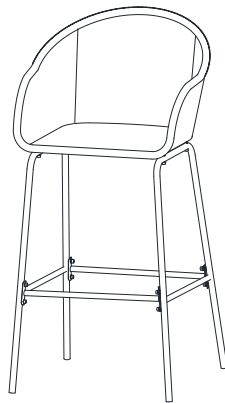
Care & Maintenance

- ⊘  ● Not for commercial use. For residential use only.
- ⊘  ● Prolonged exposure to rain may cause rusting which can stain floors.
- ⊘  ● Do not put hot items directly on furniture surface.
- ⊘  ● Do not clean furniture with harsh cleansers or polish.
- ✓  ● To obtain the longest lifespan of your outdoor products, minimizing exposure to direct sunlight is recommended.
- ⊘  ● Children should not climb or jump on the furniture.
- ⊘  ● Do not write on furniture without a padded barrier to protect the surface.
- ✓  ● To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.
- ⊘  ● Stains may be removed with mild soap solution and damp cloth.
- ✓  ● Keep away from sources of ignition.





- ✓  ● Dust and pick-up spills using a clean, non-colored, lint-free cloth.

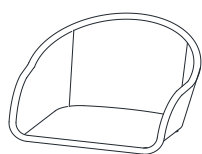

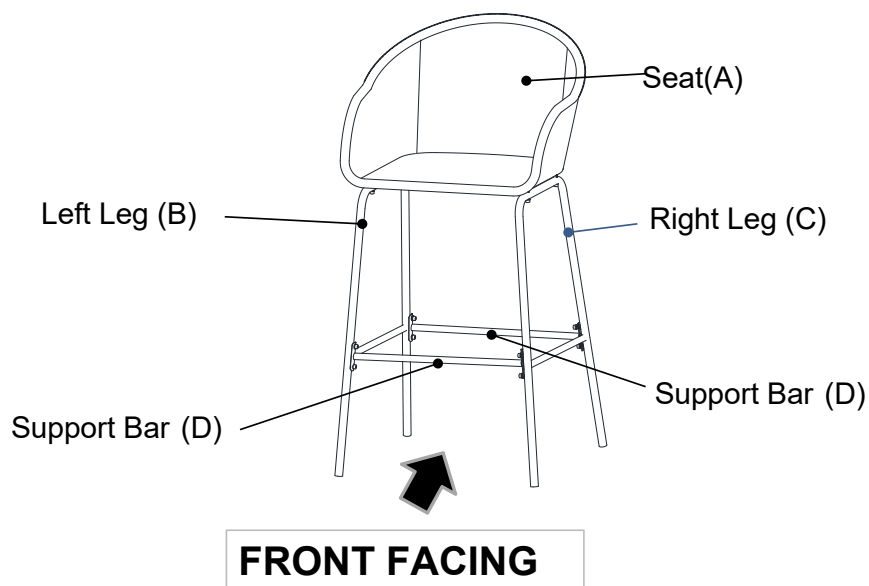
- Assemble on a clean non-marring surface (packing foam)-

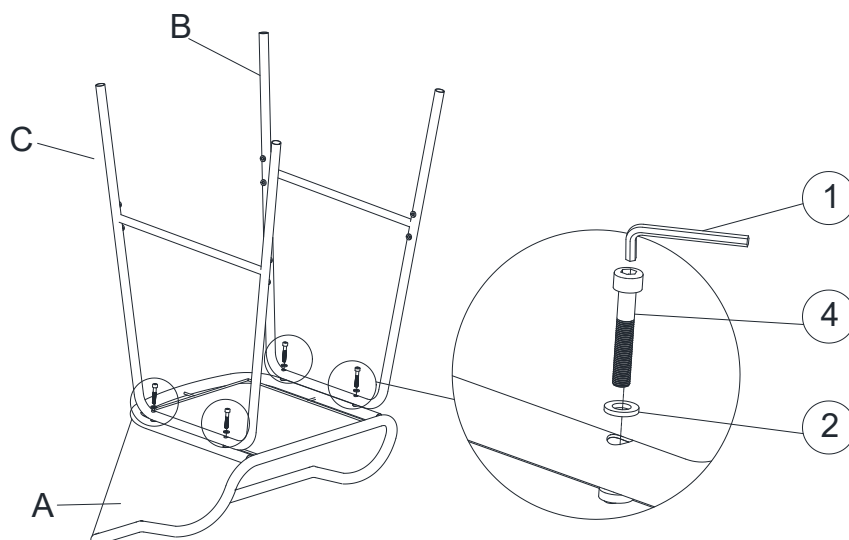
Assembly Steps

Overview



This Barstool has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Barstool parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Step 1



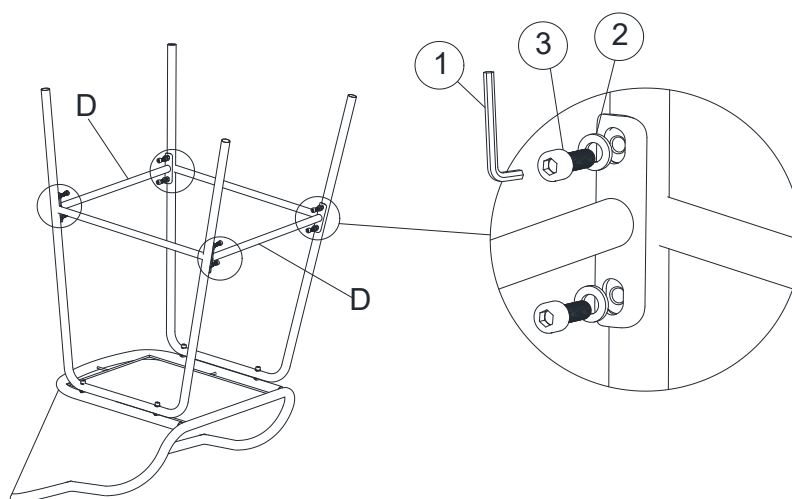
Open the carton, and place all parts onto a clean, non-marring surface.

Attach the Left Leg (B) to Seat (A) using Bolts (④) and Washers (②) with Allen Wrench (①) as shown above.

Attach the Right Leg (C) to Seat (A) using Bolts (④) and Washers (②) with Allen Wrench (①) as shown above.

Do not fully tighten the Bolts.

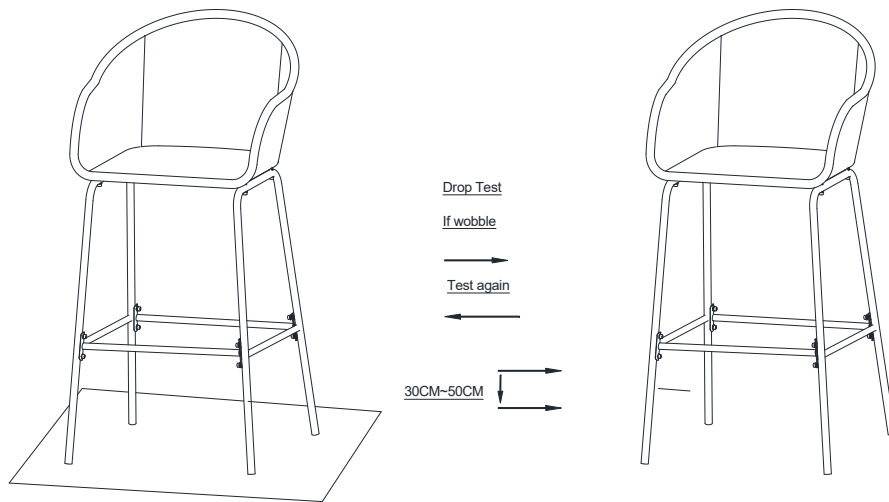
Step 2



Attach the Support Bar (D) to Left Leg (B) and Right Leg (C) using Bolts (③) and Washers (②) with Allen Wrench (①) as shown above.

Inspect and make sure all parts are adequately connected.
Fully Tighten all the Bolts.

Step 3



Stand the Barstool up.

Place the Barstool on a **LEVEL SURFACE** to check for wobbles.

If it wobbles, lift the Barstool some **30cm to 50cm** high from the ground.

Keep your feet and toes well away from the drop zone.

Drop the Barstool freely and vertically so that all four legs hit the ground at the same time.

This Drop Test will help to ensure that all the Bolts and gaps are fully aligned.

Test again for evenness on a **LEVEL SURFACE**.

If no wobbles are found, place the Barstool facedown slowly and steadily.

Then, proceed to tighten all Bolts sequentially.

When tightening the Bolts, tighten sequentially.

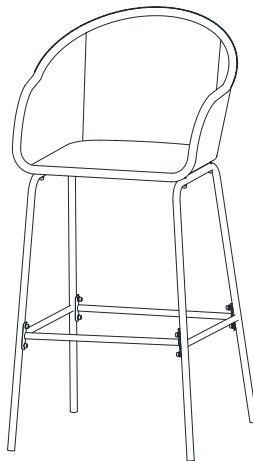
DO NOT tighten any Bolt fully and then move on to the next one.

This could cause the frame to warp.

If there are still wobbles, loosen the Bolts and execute the same drop test.

If the Barstool is not stable, it could damage the product.

Step 4



The Barstool is ready for use.

The Barstool can only be used on a flat, level surface.

Questions & Answers about Proposition 65

- What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

- What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
