Rinse it thoroughly with clean water to wash away dirt and grime. Never use abrasive cleanser on the furniture, since it can damage the surfaces and leave scratch marks.

For the stubborn grime and stains, use a soft sponge and mild soapy water, and then dry it with a cloth or paper towel.

Check the stability of screws, nuts and nut caps in priority. Tighten up them after one(1) to two(2) months' use whenever required.

Avoid improper use and be careful not to scratch or damage the surface with sharp objects.

Step 1: Attach table frame A to foot stool B using 1 bolt C, 1 spring washer E, 1 washer D. Do not screw down.

Step2: Upon completion of full assembly and bolted up-all screws can be tightened down.

If you tighten one bolt, it maybe cause other bolts out of position.









Step 1: Attach backrest A to seat B using 3 bolts D, 3 spring washers E, 3 washers C. Do not screw down.

Step2: Upon completion of full assembly and bolted up-all screws can be tightened down.
