

## Sonin ONE YEAR LIMITED WARRANTY

SONIN Inc. Warrants, to the original purchaser of this product only as follows: Sonin products are warranted to be free from defects in materials and workmanship under normal use and service for a period of 1 year from the date of purchase. SONIN Inc. at its own expense and option will either repair or replace the defective product during the warranty period, provided that the Original Purchaser has notified SONIN Inc. and, upon inspection by SONIN Inc., SONIN Inc. has found the product to be defective. The purchaser's sole and exclusive remedy hereunder shall be limited to the repair or replacement specified herein.

Any misuse, abuse, modification or attempted modification of the product shall void this warranty.

To qualify for repair or replacement of any product within one year of purchase under this limited warranty, the original purchaser must return it to the original place of purchase or to Sonin Inc. under the following guidelines:

1) Prior to the return of any defective product, obtain a Return Authorization (RA) from the customer service department at SONIN. You may obtain this authorization number by calling SONIN directly at 1-800-223-7511.

2) Return the product, at the cost of the purchaser, along with proof of purchase, to the SONIN Service Center. You may obtain the address of the SONIN Service Center when obtaining your RGA# by calling 1-800-223-7511.

Note: Goods returned without a RGA# will not be accepted.

Out of Warranty Repairs ~ or if proof of purchase is not available:

Contact Sonin's Service Center for a RA# and repair fees prior to sending your product in for repair.

Failure to obtain a RGA# may result in your product being refused by our Receiving Department.
