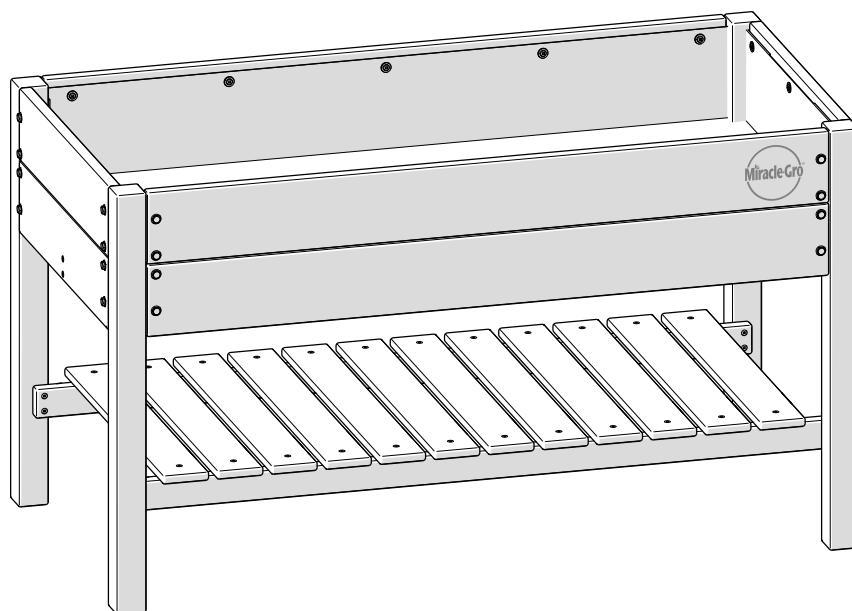




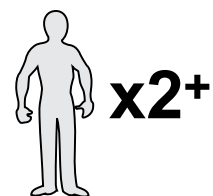

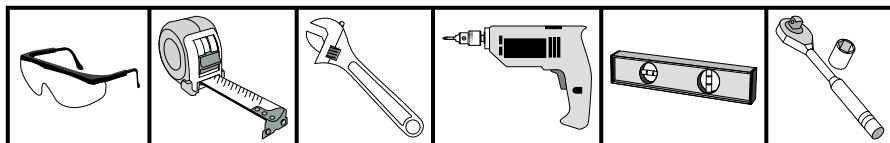

The warranty period for this product is 1 year from date of purchase.

This warranty only covers failures which occur during normal use. This warranty does not extend to color changes due to normal use, weathering or damage resulting from misuse or neglect, commercial use, failure to follow assembly instructions and/or the owner's manual (including but not limited to proper anchoring of any product, shed or building), painting, or forces of nature and other causes which are beyond the control of ShelterLogic Corp. The warranty is void if the product is modified in any way. In no event shall ShelterLogic Corp. be liable for incidental or consequential damages.

A purchase receipt or other proof of date of the original purchase will normally be required before warranty service is rendered. In no event will ShelterLogic Corp. pay for the cost of taking down the product, cost of flooring, construction labor, or any other related costs.
