Yard Gard™ Deer & Rabbit Deterrent is a granular deterrent product designed to deter burrowing and rooting animals. This product has not been registered by the United States Environmental Protection Agency. YARD GARD™ represents that this product qualifies for exemption from registration under FIFRA.

This product causes moderate eye irritation. Avoid contact with eyes or clothing. Wear protective eye-wear. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet.

## **FIRST AID**

If in Eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

## DIRECTIONS FOR USE

Apply Yard Gard™ Deer & Rabbit Deterrent to active infestations or preventatively by spreader to lawns, mulched areas, turf, golf courses, athletic fields and around shrubs. Apply Yard Gard™ in a 10-foot zone completely surrounding the plants and shrubs to be protected. Ensure the product is watered in twice a week for the first two weeks; water releases the ingredients into the soil. For best results, allow 7 to 14 days for the ingredients to migrate through the soil.

### Coverage

**Active infestations:** On the initial application, apply the product at a heavy rate of 4 lbs. per 1,000 sq ft.

**Preventative and Follow up treatments:** Apply at a medium rate of 2 lbs. per 1,000 sq ft.

Reapply product every 90 days to keep a strong residual of product in the soil.
