• Do not write on furniture without a padded barrier to protect the surface.



 To obtain the longest lifespan of your outdoor products, avoid extended and lengthy exposure to rain, snow, and direct sunshine. Whenever possible cover the product and /or place under patio or awnings.



• Stains may be removed with mild soap solution and damp cloth.



 Dust and pick-up spills using a clean, non-colored, lintfree cloth.

Please look in table for hardware packs and legs. Sets often ship in multiple boxes and may arrive a day or two apart.






Assembly Steps

Overview




This Table has multiple parts and may repuire up to 30 minutes to assemble. To give you an overview of the Table parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Step 1




Open the carton and place all the parts onto a clean, non-marring surface. Place the Table Top(A) facedown.

Step 2



Unfold the Table Leg (B) and align with pre-assembled studs on Table Top(A) with Net (1) using the Wrench (2).

Step 3



Attach the leg support(C) to Table Leg (B) Loosely tighten nuts (1) with the wrench (2), onto the feet.

Do not fully tighten the Nuts.

Step 4



Place the Table on a LEVEL SURFACE to check for wobbles.

If it wobbles, apply steady and even pressure down on the Table Top.

This action should allow all of the gaps to reach full alignment status.

When the Table is level proceed to tighten all Nuts at all joints.

When tightening the Nuts, tighten sequentially.

DO NOT tighten any Nuts fully and then move on to the next one.

This could cause the frame to warp.

If the Table is not stable it could lead to damage to the product.

Step 5



Your Table is readly for use.

This Table can only be used on a flat, level surface.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals. Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water. Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

- What types of chemicals are on the Proposition 65 list? The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.
- What does a warning mean?
 If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.
 By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
