Fire Glass Use and Care Instructions

(AFP-INST-001_REVB_12/18)

COVERAGE:

- 10-pound bag covers approximately 1 square ft x 1.25" deep.

CALCULATE HOW MUCH GLASS NEEDED FOR YOUR FIRE PIT:

- **Rectangular Fire Pit** - (Desired glass height x depth x length) ÷ 19 = pounds required
- **Round Fire Pit** - (Desired glass height x diameter x diameter) ÷ 19 = pounds required



CAUTION: Fire glass can be sharp and should be handled with caution. It is recommended to wear gloves and safety glasses while handling product.



USE RECOMMENDATIONS:

American Fire Products is the perfect way to enhance the look of an old fireplace or an old fire pit, and delight visitors at the same time.

- ¼" Fire Glass is to be used with Natural Gas or Propane fire pits or fireplaces.
- ½" Fire Glass is to be used with Natural Gas or Propane fire pits or fireplaces.
- Recycled Fire Glass is to be used with Natural Gas or Propane fire pits or fireplaces –OUTDOORS ONLY.
- American Fire Products 'Fire Beads' can be used with Natural Gas or Propane fire pits or fireplaces.
- American Fire Products 'Zircon' fire glass can be used with Natural Gas or Propane fire pits or fireplaces.
- American Fire Products '2.0 Cubed' fire glass can be used with Natural Gas or Propane fire pits of fireplaces.

INSTRUCTIONS:

1. Rinse glass to remove unwanted dust from manufacturing. Dry on towel.
2. For fire pit applications, we recommend an inch of sand or pea gravel at the bottom of the fire pit for a sturdy foundation.
3. Evenly pour fire glass over your burner. For optimal results, pour a minimum of 2-inches over your burner, which allows the gas to filter evenly through the fire glass - creating a beautiful flame.

CARE:

Little or no care is required after setting product. For an instant shine, you may sprinkle with water to remove dust. Sun covers are recommended for long term sun exposure.

The following warranty has been drafted to comply with the MAGNUSON-MOS-WARRANTY ACT applicable to products manufactured after July 4, 1975. It replaces and supersedes any warranty in this package or in any printed literature.

LIMITED WARRANTY

AMERICAN FIRE PRODUCTS, 570 THIRD STREET, LAKE ELSINORE, CA U.S.A., warrants all American Fire Products products and accessories against defects in materials and workmanship, and suitable for a particular purpose, for a period of:

1. TEMPERED GLASS – All glass is guaranteed against burnout in the original installation for the lifetime of the initial purchaser.
2. BURNERS/PANS – 5 years from date of purchase.
3. FITTINGS – 5 years from date of purchase.
4. IGNITION SYSTEM and PARTS – 1 year from date of purchase.
5. LITE STONES – 2 years from date of purchase.

THIS WARRANTY IS FOR THE BENEFIT OF THE ORIGINAL PURCHASER.

WARRANTY ADJUSTMENT:

1. AMERICAN FIRE PRODUCTS agrees to repair or furnish a replacement for, but not remove or install any product or component, which proves defective, within the above warranty and appropriate time periods stated
2. BUYER shall notify AMERICAN FIRE PRODUCTS of any defect within this warranty no later the thirty (30) days after a defect is discovered.
3. No product will be accepted for return or replacement without authorization by AMERICAN FIRE PRODUCTS. Before returning merchandise, contact AMERICAN FIRE PRODUCTS giving full details of the complaint, a copy of sales receipt, invoice or other evidence of purchase date, and an image of the item installed. Merchandise returned without proof of purchase date will be serviced out of warranty at our prevailing service and part rates. If merchandise was damaged in transit, file claim immediately with the carrier, and contact AMERICAN FIRE PRODUCTS. Product returned must be addressed as follows:

2.
