
Stains may be removed with mild soap solution and damp cloth.





Overview:




This chair has multiple parts and may require up to ten minutes to assemble. To give you an overview of the chair parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.




Open the carton and place all the parts on a clean, non-marring surface.

Turn the Chair Seat and Back (A) upside down as shown above.



Attach the Seat Connection (D) to the Chair Seat and Back (A),using Bolts(1) and Washer(2) with Allen Wrench(3) as shown above.

Fully Tighten all the bolts after all bolts are in place.




Attach the Left Leg (B) to the Chair Seat and Back (A), using Bolts(1) and Washer(2) with Allen Wrench(3).

Attach the Right Leg (C) to the Chair Seat and Back (A), using Bolts(1) and Washer(2) with Allen Wrench(3).


Fully Tighten all the bolts after all bolts are in place.

Step 4



Place the Cushions(E) to the Chair Seat and Backs (A) and fix them with cushion ties as shown in the picture

Step 5



Turn the Chair up and place the Chair on a LEVEL SURFACE.

Inspect it and make sure all parts are adequately connected.

Gently and carefully tap the seat and check for wobbleness.

If there is wobbling, loosen the bolts and tighten all bolts in a sequential manner.

If there is still wobbling, loosen the bolts and repeat the same process.

The Chair is ready to be used.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

· What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
