Stains may be removed with mild soap solution and damp cloth.




Keep away from sources of ignition.



. Do not assemble on flooring or carpet-




· Assemble on a clean non-marring surface (packing foam)-



· Save all packaging until finished-


Assembly Steps




This Club Chair has multiple parts and may require up to 30 minutes to assemble.

To give you an overview of the Club Chair parts, the above picture is to help you put the various parts into perspective.

Please read through the instructions below to familiarise yourself with the parts and steps before assembly.




Unpack and place all parts on a clean, non-marring surface.



Place the Left Leg Panel (B) upright as shown in the picture above onto a clean, soft surface to avoid any scratches or damages to the product.

With the help of your adult partner, insert the tenon of Seat Support Bar (D) into the mortise of Left Leg Panel (B) as shown above.

Then attach Left Leg Panel (B) to Seat Support Bar (D) with Screw (②) using Allen Wrench (⑤). **DO NOT fully tighten the Screws.**




Place the Right Leg Panel (A) upright as shown in the picture above onto a clean, soft surface to avoid any scratches or damages to the product.

3.1) With the help of your adult partner, insert the tenon of Seat Support Bar (D) into the mortise of Right Leg Panel (A) as shown above.

Then attach Right Leg Panel (A) to Seat Support Bar (D) with Screw (2) using Allen Wrench (5).


3.2) Attach Right Leg Panel (A) to Left Leg Panel (B) with Bolt (3) and Washer (4) using Allen Wrench (5).

DO NOT fully tighten the Screws and Bolts.



With the help of your adult partner, place Seat Panel (C) to the assembled part in Step 2&3 and then attach Seat Panel (C) to Right Leg Panel(A) and Left Leg Panel(B) with Screws (1) using Allen Wrench (5) as shown above.

DO NOT fully tighten the Screws.



Inspect it and make sure all parts are adequately connected.


Turn the Club Chair right side up, with assistance from your adult partner.

Exert pressure floor wards, onto the Club Chair with both your hands.

This will help to align all the parts at all joint areas.

In a sequential manner, gradually tighten all Screws and Bolts at all joints until evenly connected.

Adjust Pre-installed Leveler height for balance until the Club Chair is level with the ground.



Place the Seat Cushion (E) by affix the Magic Tape Straps on the Seat Panel (C) and then place the Back Cushion (F) onto the Seat Cushion (E) as shown above.

WARNING!! IF CLUB CHAIR IS NOT STABLE, IT COULD LEAD TO DAMAGING THE PRODUCT. Your Club Chair is ready for use.

This Club Chair can only be used on a flat, level surface.

Questions & Answers about Proposition 65

What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals.

Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water.

Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

• What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals.

By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
