### **PRODUCT ASSEMBLY**



Place the part F on the part G , Plastic parts are placed under the Part G Use part A, part B, part C screw fittings to fix the connection between part H and part F.G.



Connect part E to part H, and tighten it with par open the wrench, grab the hand and pull the umbrella up.



until the umbrella is fully open, when out of use, crank the handle counterclockwise until the umbrella is fully retracted and pull the sleeve on the shaft outward.



Fill the 4 triangle bases we equipped with sand (maximum weight of each piece after sand filling is 26.5 pounds) and then place them on our crossbar. Warm tip: after filling the sand, and then again filling water into them, the effect will be better.



Before opening, tidy the umbrella ribs and umbrella cloth to separate thempush up the position of the rocker and the plastic part on the umbrella pole simultaneously, and then lock the sleeve on the umbrella pole. Finally, lock the wrench.



Hold the handle in place, pull the umbrella down, and secure it with the Velcro strap on the canva.
