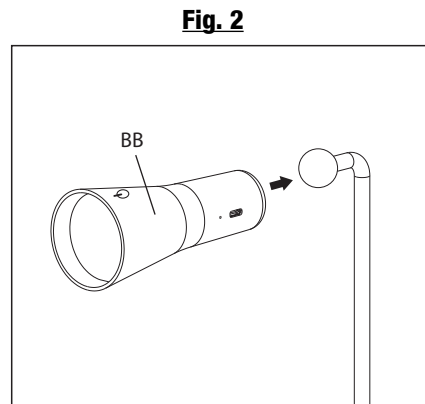
## 1 Attach the metal stand to the base

Screw the Metal Stand (AA) into the Base (CC) by turning the Metal Stand (AA) clockwise (see Fig 1).




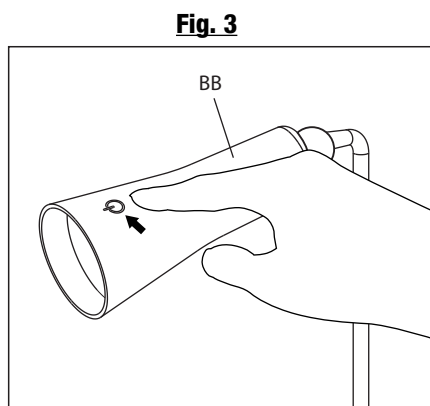
## 2 Attach the lamp shade to the magnetic ball

Place the Lamp Shade (BB) close to the magnetic ball to connect (see Fig 2).



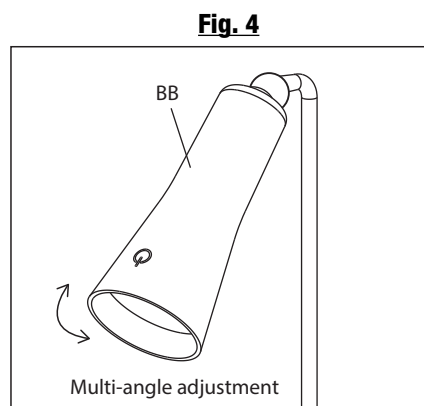
## 3 Cycling through the light settings

Touch the  button on the Lamp Shade (BB) to cycle through the light settings: Low > Medium > High > OFF (see Fig. 3).



## 4 Adjusting the lamp shade

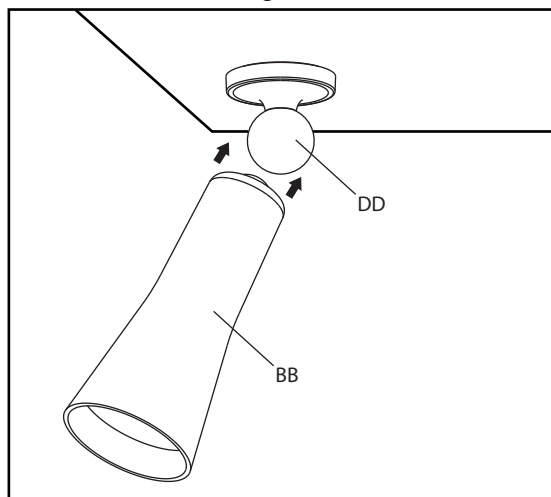
Gently rotate the Lamp Shade (BB) to the desired angle (see Fig 4.)



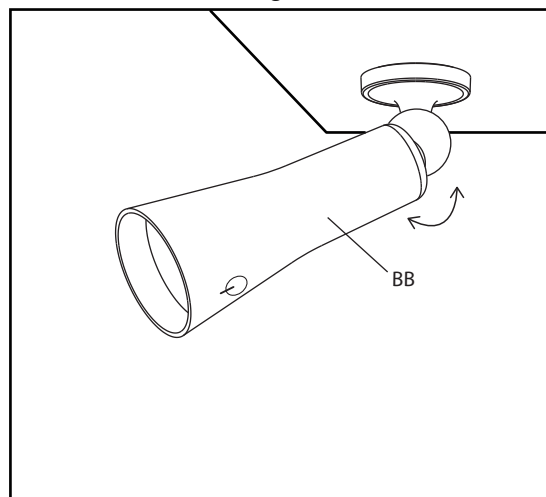
## 5 Attach using the sticky mounting base

Place the Lamp Shade (BB) close to the Sticky Mounting Base (DD) magnetic ball to connect (see Fig 5). Gently rotate the Lamp Shade (BB) to the desired angle (see Fig 6).

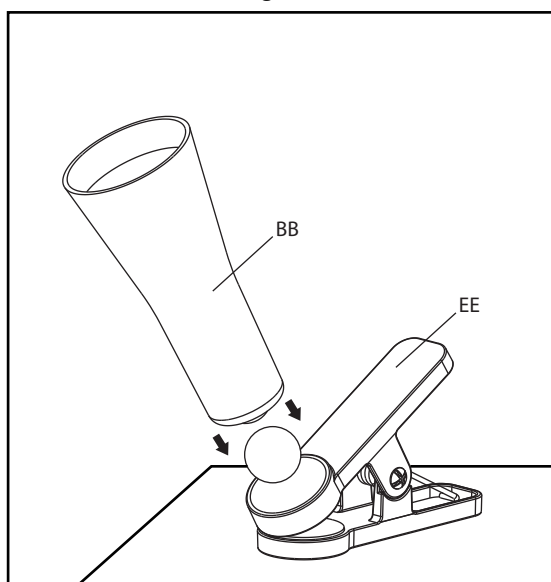


**NOTE:** Prior to installing surface must be flat and clean. Press down and hold for 10 seconds to make sure it sticks.

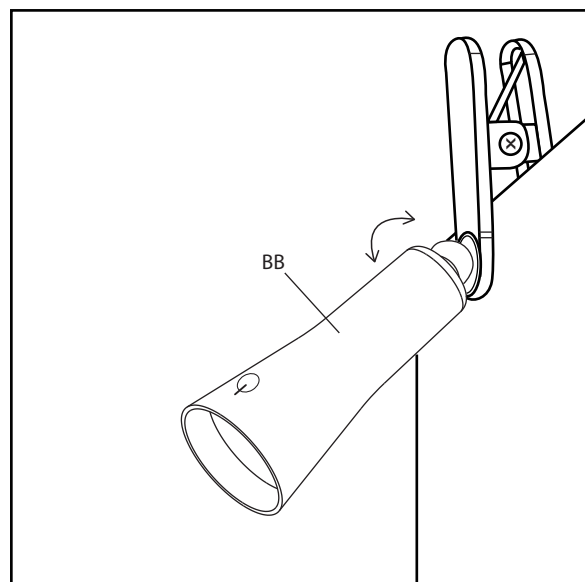
## 6 Attach using the clip stand

Place the Lamp Shade (BB) close to the Clip Stand (EE) magnetic ball to connect (see Fig 7). Gently rotate the Lamp Shade (BB) to the desired angle (see Fig 8).

**NOTE:** For best results, mount to a secure location and make sure the surface is not slick or wet.
