

25 YEAR LIMITED PRODUCT WARRANTY

Products.

This limited warranty covers Shakertown® siding panels. The warranty is extended to the original homeowner only, from the date of completed installation.

Terms of Warranty.

Subject to the limitations and exclusions set forth in this warranty, Shakertown 1992, Inc. warrants to the original homeowner that the Shakertown siding panels are free from manufacturing defects that would adversely affect the normal performance of the siding. The pro-rata warranty period for Shakertown siding panels is 25 years.

Remedies.

If warranted Shakertown siding panels fail within the warrantable period due to manufacturing defects, Shakertown 1992, Inc., at its sole election, will furnish replacement panels or refund a pro-rata portion of the amount the original homeowner paid for the panels.

The pro-rata refund works as follows:

Within the first year of the Warranty Period, Shakertown 1992, Inc. will pay 100% of the original cost of the damaged panels, described under Terms of Warranty. During the remaining Warranty Period, Shakertown 1992, Inc. will pay a pro-rata share of the original costs of the damaged panels, based upon the percentage of the Warranty Period remaining.

Limitations and Exclusions from Warranty.

Shakertown 1992, Inc.'s only obligation under this Limited Warranty shall be to replace such quantity of the Shakertown siding panels as is proven to be defective by reason of manufacturing defect.

This warranty does not cover:

- 1. Improper installation.** All Shakertown siding panels must be applied in accordance with manufacturer's recommendations and those described in the Uniform Building Code.
- 2. Improper use.** Any panels not used for normal wall applications or mansards with a 60 degree slope or steeper.
- 3. Ancillary costs.** The costs of any tear-off, installation, vents, flashings, underlayments, fasteners or any other related materials.
- 4. Acts of God.** Product failure caused by hurricane, tornado, lightning, flood, fire, falling objects, civil commotion, or acts of God.
- 5. Structure failure.** Product failure caused by settling, warping or distortion of the building.
- 6. Neglect.** Product failure due to improper handling, use, or maintenance, including the buildup of moss, dirt and other debris.
- 7. Modifications.** Product failure due to repairs or alterations of walls after initial installation.
- 8. Color.** Shakertown siding panels are made from natural wood, of which Shakertown 1992, Inc. has no control in the natural color hues or variances.
- 9. Other products.** Product failure caused by flashings, vents, underlayments, skylights, solar heating apparatus, paints, coatings, solutions, etc.

10. Consequential Damage. Any damage of any kind whatsoever, including damage to the interior or exterior of the building.

11. Damages of any kind suffered by anyone other than the original owner.

12. Factors beyond the manufacturer's control.

The serviceable life of siding materials may be affected by climate index, installation practices, improper maintenance, ventilation, underlayments and other conditions which affect wear and tear. Shakertown 1992, Inc. is not responsible for these factors causing product failure or damage.

SOLE WARRANTY.

THIS WARRANTY IS EXCLUSIVE AND REPLACES ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED BY LAW, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR USE OR PURPOSE. NO REPRESENTATIVE, EMPLOYEE OR AGENT OF SHAKERTOWN 1992, INC., OR ANY OTHER PERSON, HAS AUTHORITY TO ASSUME FOR SHAKERTOWN 1992, INC. ANY ADDITIONAL LIABILITY OR RESPONSIBILITY IN CONNECTION WITH PANELS BEYOND THAT SET FORTH ABOVE. IN NO EVENT, WHETHER FOR BREACH OF THIS WARRANTY, NEGLIGENCE OR FOR ANY OTHER CAUSE, WILL SHAKERTOWN 1992, INC. BE LIABLE FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND. SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE EXCLUSIONS OR LIMITATIONS MAY NOT APPLY TO YOU.

Notification of Claims.

Claims pursuant to this warranty must be submitted in writing, together with proof of purchase, installation dates, and applicable maintenance records, to the Shakertown 1992, Inc. address set out below, within 30 days after discovery of the failed panels. Shakertown 1992, Inc., within a reasonable length of time of notification of failure, will investigate the claim, and, if Shakertown 1992, Inc. determines that any defects are covered by this warranty, Shakertown 1992, Inc. will resolve the complaint in accordance with the terms of this warranty within a reasonable amount of time. Shakertown 1992, Inc. will not be liable for unauthorized replacement or the cost of replacement incurred prior to written acknowledgment by Shakertown 1992, Inc. that it will replace the defective panels.

Care & Maintenance Recommendations

Home Repairs - When making home repairs, renovations, remodeling or other activities that affect siding, be sure to comply with Shakertown's application recommendations..

Caulk Repairs - When caulking needs repair use a non-hardening caulk. Remove loose caulk. Install caulking in accordance with the caulk manufacturer's recommendations.

Loose Siding - Loose siding or shingles are easily secured using a hot-dipped galvanized or stainless steel 7d siding nail. Refer to Shakertown application recommendations.

Cleaning - Dirt, debris, mold, mildew or other conditions common to all siding materials are easily removed from using a soft brush with a mild cleanser. Local paint stores can supply you cleaners specific for cedar siding if you experience stubborn mold or mildew. Always test a small hidden area of the siding before cleaning the entire wall.

Stains and Paints - All siding products will last their full life when stained or painted. These stains and paints have limited life spans and will have to re-applied from time to time. Refer to your selected finish manufacturer recommendations for proper application periods, application methods and application rates.
