

Project Source™ Vinyl Window & Patio Door Limited Warranty

IMPORTANT NOTICE: Read this entire Project Source[™] Limited Warranty and Limitation of Liability ("Limited Warranty") before purchasing or installing this product. By installing this product, you acknowledge that this Limited Warranty is part of the terms of sale. This Limited Warranty applies to Vinyl Windows and Patio Doors manufactured by Project Source[™] and installed within the United States and Canada.

LIMITED WARRANTIES FOR PRODUCTS INSTALLED IN OWNER-OCCUPIED SINGLE-FAMILY HOMES

This Limited Warranty applies exclusively to vinyl windows and patio doors manufactured by Project Source™. Project Source™ offers this Limited Warranty for its vinyl windows and patio doors installed in owner-occupied single-family homes within the United States and Canada.

Non-Glass Materials and Workmanship - Nontransferable Limited Warranty

All non-glass components, including vinyl frames and hardware for Project Source™ windows and doors will be free from defect in material or workmanship that significantly impair their proper operation and function for as long as the Buyer owns and occupies the home where the products are installed.

Insulated Glass Materials and Workmanship - Nontransferable Limited Warranty

The insulated glass is warranted not to fail for a period of 15 years from date of purchase. This Limited Warranty applies to glass with significant obstruction of vision that results from moisture film or dust buildup between the glass surfaces.

It is known that argon within insulating glass dissipates over time and Project Source™ makes no warranty regarding the rate of dissipation of argon or the amount of argon remaining at any time following manufacture of the unit.

If Project Source™ receives notice of a defect in materials or workmanship in a vinyl window or door manufactured by Project Source™, the company will, at its sole discretion:

- 1. Repair or replace the defective part(s) or product(s); or
- 2. Refund the original purchase price.



This Limited Warranty is exclusive to the original Buyer and is non-transferable. Vinyl windows and doors manufactured by Project Source™ installed in non-owner-occupied residences and glass components are not covered under this Warranty.

Installation Requirements: Proper installation is critical to the performance of Project Source™ products. All installation instructions provided by Project Source™ must be strictly followed to ensure warranty coverage. Any deviations or noncompliance with these guidelines may result in the voiding of this warranty.

What is not covered by this Limited Warranty

- Failure due to product modifications by owner or installer
- Improper use or maintenance
- Exposure to conditions beyond unit performance specifications
- Failure to properly install and seal during installation
- Fading and color variations caused by typical aging
- Improper storage, handling, installation, and use

PRODUCT INSPECTION PROCEDURE

All products must be thoroughly evaluated and inspected upon receipt. Any damage, defects, or operational failures must be reported to Project Source™ immediately. The inspection should include a detailed review of all components, including frames, glass, hardware, and finishes. Any irregularities, visible defects, or functional failures must be documented with descriptions and supporting photographs.

CONDITIONS APPLICABLE TO ALL SALES OF COVERED PROJECT SOURCE™ PRODUCTS AND LIMITED WARRANTIES

Limitation of Warranty

FAILURE TO ADHERE TO PROJECT SOURCE™ INSTALLATION AND MAINTENANCE INSTRUCTIONS WILL VOID ALL WARRANTIES UNLESS THE BUYER OR USER CAN DEMONSTRATE THAT THE DEFECT OR FAILURE IS UNRELATED TO SUCH NONCOMPLIANCE.



This Limited Warranty does not cover the use of Project Source™ products under abnormal conditions, exceeding the stated performance parameters provided on product labeling and in the Project Source™ Architectural Design Manual, or under circumstances not reasonably foreseeable to or beyond Project Source's control. The Buyer and User assume all risks related to such use.

This Limited Warranty provides specific legal rights, and you may have additional rights that vary by state.

Prompt Notice of Claim

Claims not reported within this timeframe will be barred.

How to File a Claim

Owner Information

- 1. Property Owner's full name
- 2. Property Owner's address
- 3. Property Contact phone number
- 4. Installation address (if different from owner's address)

Product Information

- 1. Product model number
- 2. Product SKU
- 3. Proof of purchase (receipt, invoice) including date and location of purchase

Issue Details

- 1. Detailed description of the issue
- 2. Supporting photos clearly showing the problem

Additional Notes

- **Supporting Documents:** Proof of purchase must be in **PDF, JPEG, or PNG format** and clearly show the date and location of purchase.
- On-Site Inspection Fee: Project Source™ may charge a fee for on-site product inspections if the issue falls outside warranty coverage or requires a technician visit.
- **Processing Time:** Once submitted, claims will be reviewed within **7-10 business days**. After processing, Project Source™ will contact you with further instructions.
