WHAT IS COVERED?

Miseno warrants to the ORIGINAL CONSUMER PURCHASER that its faucets (except as explained under paragraph 3, below) shall be free from defects in material and workmanship under normal use and service FOR SO LONG AS THE FAUCET IS USED IN ITS ORIGINAL RESIDENTIAL INSTALLATION. If the faucet is used in industrial, commercial or business applications, the preceding sentence does not apply, but rather FOR ALL INDUSTRIAL, COMMERCIAL OR BUSINESS APPLICATIONS, THE WARRANTY SHALL BE A FIVE (5) YEAR LIMITED WARRANTY FROM THE DATE OF PURCHASE WITH ALL OTHER TERMS AND EXCLUSIONS OF THE WARRANTY APPLICABLE.

COMPANY'S OBLIGATIONS
