Lifetime Limited Warranty

This warranty gives you specific legal rights, and you may also have other legal rights which vary from state to state. Eurowindowsgroup warrants to you, the original purchaser of the Eurowindowsgroup Windows or Patio Doors, that this product will be free from defects in material and workmanship for as long as you own and reside in the home in which the products were installed as follows:

BASIC FRAME OF WINDOW UNIT OR PATIO DOOR - LIFETIME: The rigid vinyl in the window or patio door is warranted against chipping, cracking, peeling, pitting, warping or blistering for as long as you own and reside in the house in which these products were installed, for so long as these products are properly maintained. This limited warranty is not applicable to damage caused by accident, fire, flood, acts of God, explosion, misuse, abuse, vandalism, riots, civil disorder, pollution or other external forces or to damage due to improper installation or improper, incomplete or negligent maintenance.

MOVING PARTS - LIFETIME: Moving parts, as such balances that are used on tilt and turn windows and locking mechanisms used in all windows or patio doors, are warranted for as long as you own and reside in the house in which the products were installed. This limited warranty is not applicable to normal wear and tear or to any damage caused by improper installation, improper cleaning, accident, fire, flood, acts of God, explosion, misuse, abuse, vandalism, riots, civil disorder, pollutions or other external forces.

FIBERGLASS SCREENS - LIFETIME: The materials used in manufacturing screens are warranted for manufacturing defects for as long as you own and reside in your present home. This warranty is not applicable to any damage caused by improper installation, accident, fire, flood, acts of God, explosion, misuse, abuse, vandalism, riots, civil disorder, pollution or other external forces, and the warranty shall be limited to providing you with new screen material and/or frames or spline for any manufacturing defect in the screen.

INSULATED GLASS UNIT - LIMITED LIFETIME The sealed insulated glass unit is warranted against defects resulting in material obstruction of vision from film formation caused by dust or moisture in the sealed unit which exceed the federal specification C 1036-90, for as long as you own and reside in the residence in which the windows were originally installed. This warranty excludes seal failure due to broken glass and condensation on the glass. Should glass fail at any time up to the 15th anniversary year from the date of original purchase, then Eurowindowsgroup LLC will provide you with a replacement sealed glass unit at no charge to you for the replacement unit. After the 15th anniversary, should your insulated glass unit fail, then Eurowindowsgroup LLC will charge you a fixed percentage of the selling price for the window according to the following formula: Years 16 through 30 - 80%; Beyond 20 years - 90%. This warranty is limited to providing you with replacement parts. Installation of the parts is the responsibility of either the homeowner or the company (Dealer) from whom the product was purchased.

BAY, BOW AND GARDEN WINDOWS: All moving parts are warranted as described on the front under "MOVING PARTS". All insulated glass units are warranted as described on the front under "INSULATED GLASS UNIT". All vinyl-framing components are warranted as described on the front under "BASIC FRAME OF WINDOW UNIT OR PATIO DOOR". Window frames are warranted to be structurally sound for 15 years from date of original purchase. This limited warranty is not applicable to damage caused by improper installation, accident, fire, flood, acts of God, explosion, misuse, abuse, vandalism, riots, civil disorder, pollution, or other external forces or to damage due to improper, incomplete or negligent maintenance. CONDENSATION: Condensation on any window or patio door is the natural result of excessive moisture in the house, and does not indicate a defective product or faulty installation. Excessive condensation may even result in frost appearing on windows in cold weather. Eurowindowsgroup LLC is not responsible for condensation and this warranty does not apply to condensation, its causes or its effects. Additional information concerning condensation is available upon request.

CAULKING: Eurowindowsgroup LLC does not warrant caulking.

CLEANING: To clean glass, use soft cloth with glass cleaner or vinegar/water solution. To clean vinyl, use mild soapy water solution, rinse with clear water and dry with clean paper towels. There is no need to use standard household cleaners. This warranty does not apply to damage due to improper, incomplete or negligent cleaning. COLOR: The vinyl will maintain its manufactured color closely as it ages. However, atmospheric pollution and residues deposited on the windows can temporarily discolor it. Mild soaps or detergents are usually all that are necessary to restore its lustrous manufactured color.

INSTALLATION: Eurowindowsgroup LLC does not warrant the installation of the products you

have purchased it warrants manufactured parts only. Installation of warranty parts is the responsibility of either the homeowner or the company (Dealer) from who the products was purchased.

PROCEDURE: Please consult the Eurowindowsgroup LLC Customer Service Department for a determination as to whether or not components need to be shipped to our factory. Eurowindowsgroup LLC reserves the right for final approval on warranty claims involving components. A visual inspection by an authorized representative of Eurowindowsgroup LLC may or may not be required. If an inspection is necessary and substantiates that the material has failed, and is covered under warranty, a replacement part will be shipped to our designated distributor closes to you at no charge, except for freight involved. Replacement items may differ slightly from the original window part as to technological progress. This limited warranty is made in lieu of all other express warranties, and extends only to the original consumer's purchase. In no event shall Eurowindowsgroup LLC be liable for special incidental or consequential damages, or for any delays in the performance of the warranty due to circumstances beyond its control.

IMPORTANT NOTICE: Windows that exceeds the manufacturer's specified sized limitations are not covered under this warranty.

NOTE: Some states do not allow limitations on how long an implied warranty lasts, or the exclusions, limitations of incidental or consequential damages for that the above limitations or exclusions may not apply to you. This lifetime limited warranty shall not be effective unless you complete and return this attached registration card within 30 days of installation.

This warranty may be validated by having the Registration Certificate signed by the original Purchaser-Property Owner and the dealer and mailing to Eurowindowsgroup LLC within thirty (30) days of the completed installation. The original warranty period shall not be extended by any such repair or replacement. Eurowindowsgroup LLC replacement products warranty does not cover any Eurowindowsgroup LLC products that are installed in buildings operated such as multi-family dwellings or used for commercial purposes or rental properties such as schools, churches, apartment complexes, government owned structures, office buildings, etc.

TRANSFER OF WARRANTY

The original purchaser of the Eurowindowsgroup LLC windows and patio doors may transfer the warranty to the first subsequent owner of the premises for a period of five years from the date of installation. In order to transfer the warranty the "Warranty Registration" card below must be on file at Eurowindowsgroup LLC from the original purchaser. An "Addendum of Warranty Transfer" (available from the dealer the windows were purchased from) must be filled out and sent to Eurowindowsgroup LLC with a \$75.00 transfer fee within 20 days of the closing. The warranty period post-transfer shall be limited to the unexpired remaining portion of the warranty. The warranty's coverage period shall not be extended by any claim.
